

ORDINANCE NO. 01-2018

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER II OF THE REVISED
GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND
ENTITLED "ADMINISTRATION, SECTION 2-24 ENTITLED
"DEPARTMENT OF POLICE OR POLICE DEPARTMENT"**

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration"; Section 2-24 entitled "Department of Police or Police Department", and

WHEREAS, after consultation with the Chief of Police, the Mayor and Council of the Borough of Roseland wish to alter the composition of the Police Department;

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration", Section 2-24 entitled "Department of Police or Police Department" shall be amended as follows:

SECTION I

That section 2-24.2, entitled "Composition" shall be amended to add the following **thus** and to delete the following **thus**:

2-24.2 Composition.

The composition of the Police Department shall be established by the Borough Council, after consulting **with** the Chief of Police. The Borough of Roseland Police Department shall consist of no more than one (1) Chief, two (2) **Patrol** Captains, ~~two (2)~~ **one (1)** Patrol Lieutenants, one (1) Detective ~~Lieutenant~~ **Captain**, one (1) Detective Sergeant, five (5) Patrol Sergeants, two (2) Detectives, and seventeen (17) Patrol Officers. The Police Department will employ no more than six (6) Civilian Dispatchers and one (1) Administrative Assistant to the Chief of Police.

SECTION II

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect in accordance with applicable law.




