

**ORDINANCE NO. 02-2016**

**BOROUGH OF ROSELAND  
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE TO AMEND CHAPTER VI OF THE  
REVISED GENERAL ORDINANCES OF THE BOROUGH OF  
ROSELAND ENTITLED "ALCOHOLIC BEVERAGE  
CONTROL", AMENDING SECTION 6-3.4 ENTITLED  
"LICENSE FEES; MAXIMUM NUMBER"**

**WHEREAS**, Section 6-3.4 , entitled "License Fees; Maximum Number" of Chapter VI of the Revised General Ordinances of the Borough of Roseland entitled "Alcoholic Beverage Control", sets the amount of the Alcoholic Beverage License Fees; and

**WHEREAS**, the Mayor and Council of the Borough of Roseland wish to amend the Alcoholic Beverage License Fees to reflect the maximum statutory limit because said fees have not been adjusted since 2004; and

**WHEREAS**, the annual fee for renewal of a Plenary Retail Consumption License and a Plenary Retail Distribution License may not be raised more than 20% from the fee charged the preceding year; and

**NOW, THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Roseland that Section 6-3.4 , entitled "License Fees; Maximum Number" of Chapter VI of the Revised General Ordinances of the Borough of Roseland entitled "Alcoholic Beverage Control", shall be amended as follows:

**SECTION I**

That section 6-3.4, entitled "License Fees; Maximum Number" shall be amended to add the following **thus** and to delete the following **thus**:

**6-3.4 License Fees; Maximum Number.**

The annual license fees and maximum number of licenses for the sale or distribution of alcoholic beverages in the Borough shall be as follows:

**SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect upon publication as provided by law.




