

ORDINANCE #03-2015

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER VII ENTITLED
“TRAFFIC”, SECTION 7-20 ENTITLED “STOP INTERSECTIONS”
(INTERSECTION OF CANOE LANE AND OAK DRIVE)**

WHEREAS, Section 20 of Chapter VII of the Revised General Ordinances of the Borough of Roseland currently designates Stop Intersections pursuant to the provisions of N.J.S.A. 39:4-140; and

WHEREAS, the Roseland Chief of Police has recommended to the Mayor and Council that the intersection of Canoe Lane and Oak Drive be designated as a Stop Intersection;

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Roseland that Section 7-20 “Stop Intersections” of the Revised General Ordinances of the Borough of Roseland, Chapter VII “Traffic” shall be amended as follows:

That section 7-20 Stop Intersections shall be amended to **add** the following:

SECTION I

7-20 STOP INTERSECTIONS.

Pursuant to the provisions of N.J.S.A. 39:4-140, the intersections described are hereby designated as Stop Intersections. Stop signs shall be installed as provided therein. (1973 Code § 9-4A; New; Ord. No. 1-2001 § 1; Ord. No. 11-2002; Ord. No. 15- 2002; Ord. No. 4-2004; Ord. No. 15-2011 § 1)

Mitchell Avenue and Monroe Avenue

Morgantine Road and Pitcairn Drive (Ord. No. 13-2012)

Park Street (Westbound) at Cortlandt Street

Stop sign(s) on

Condit Court

Canoe Lane at East end where it intersects with Oak Drive

Davenport Avenue South

Williamsburg Drive

Davenport Avenue

Evelyn Road at the southwest side where it intersects with Oak Drive

Lyons Avenue

Mitchell Avenue

Morgantine Road-North End

Park Street

Plymouth Place and Godfrey Avenue
Roseland Place and Godfrey Avenue
Westview Avenue and Femwood Avenue

SECTION II

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect immediately upon passage and publication as provided by law.
