

ORDINANCE NO. 08-2016

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER II OF THE REVISED GENERAL
ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED
“ADMINISTRATION”, AMENDING SECTION 2-55 ENTITLED “SENIOR
CITIZENS’ ADVISORY BOARD” TO REDUCE THE NUMBER OF
MEMBERS FROM TWELVE (12) TO EIGHT (8)**

WHEREAS, Section 2-55.1, entitled “Creation”, of Chapter II of the Revised General Ordinances of the Borough of Roseland entitled “Administration”, establishes the number of members of the Senior Citizens’ Advisory Board; and

WHEREAS, the Mayor and Council of the Borough of Roseland wish to reduce the number of members of the Senior Citizens’ Advisory Board;

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Roseland that Section 2-55.1, entitled “Creation”, of Chapter II of the Revised General Ordinances of the Borough of Roseland entitled “Administration”, shall be amended as follows:

SECTION I

That section 2-55.1, entitled “Creation” shall be amended to add the following **thus** and to delete the following **thus**:

2-55.1 Creation.

There is hereby created a Senior Citizens' Advisory Board which shall consist of ~~twelve (12)~~ **eight (8)** members, to be appointed by the Mayor, with advice and consent of the Council, for the respective terms of three (3) years or until his successor shall have been appointed and qualified.

SECTION II

If any section or provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect upon publication as provided by law.


