COUNCIL MEETING MINUTES

The November 21, 2023 meeting of the Roseland Mayor and Council was called to order at 6:30 PM by Mayor Spango. This meeting was also available via Zoom conference call.

EXECUTIVE SESSION

SWEARING IN CEREMONY – POLICE OFFICER

Mayor Spango administered the Oath of Office to new police patrol officer Gregory Matesic.
