INTRODUCTION OF ORDINANCES

Councilwoman Fishman made a motion to introduce Ordinance No. 02-2024: "An ordinance amending Chapter 2 of the Revised General Ordinances of the Borough of Roseland entitled "Department of Administration", amending Subsection 2-24.4 entitled "The Appropriate Authority and the Police Committee". The motion was seconded by Councilwoman Perrotti and approved by a 6-0 voice vote. The public hearing will be held on March 19, 2024.

Councilman Bardi made a motion to introduce Ordinance No. 03-2024: "An ordinance amending Section 2-39 of the Revised General Ordinances of the Borough of Roseland entitled "Nepotism Police for Borough Employees". The motion was seconded by Councilman Trillo and approved by a 6-0 voice vote. The public hearing will be held on March 19, 2024.

Councilwoman Fishman made a motion to introduce Ordinance No. 04-2024: "An ordinance to amend Chapter 30 "Land Development" Article IV "Zoning" regarding the rezoning of Block 32, Lot 9.01 from R-6 to B-2, the rezoning of Block 30.01, Lot 3 from R-2 to OB-2, and the repeal of the R-2A single family overlay district". The motion was seconded by Councilwoman Perrotti and approved by a 6-0 voice vote. The public hearing will be held on April 23, 2023.

MAYOR'S REPORT

Mayor Spango congratulated all of the children in attendance on their respective championships.

COMMITTEE REPORTS

FINANCE & ADMINISTRATION

Councilman Bardi reported that Council held its third budget meeting this past Saturday and the date of the fourth and final budget meeting will be announced.

RECREATION

Councilman Trillo reported that the regular basketball season has concluded and that the basketball playoffs will be concluding within the next couple of weeks. Baseball and softball registration have begun and will run through March 1st.

SENIOR & FAMILY SERVICES

Councilwoman Fishman announced that the seniors have been provided a lot of interesting programs to date. The next event will be a celebration of St. Patrick's Day in March, followed by the annual senior luncheon on May 17th.

PUBLIC WORKS

Councilman Freda had no report. Mr. Freda announced his resignation from Council effective following the conclusion of the meeting. Members of Council thanked Mr. Freda for his service and wished him well in the future.

PUBLIC SAFETY

Councilwoman Perrotti thanked Officer Conzentino and Officer Gonzalez for the wonderful job they did last December. Mrs. Perrotti thanked the Roseland Police Foundation for their donation of license plate readers in the past, and for their recent donation of gun sights. Police dispatch was transitioned to the West Caldwell Police Department last Tuesday and is running smoothly. Councilwoman Perrotti thanked Police Director Cioffi and Assistant Director Matheis for coordinating the transition. This shared service agreement will result in more police officers on the road for patrol in Roseland.

CAPITAL INFRASTRUCTURE & ENGINEERING

Councilman Biront noted that he reviewed the plans for upcoming improvements to Lincoln Street and provided comments to the Borough Engineer.

Mayor Spango expressed his support for the upcoming vote on the school referendum, noting that one third of the cost will be for improvements to the existing school, and two thirds of the cost will be for the construction of additional classroom space.

Councilman Bardi made a motion to approve the February 6, 2024 caucus meeting minutes, the February 6, 2024 executive session minutes, and the February 20, 2024 budget meeting minutes. The motion was seconded by Councilwoman Perrotti and approved by a 5-0 voice vote with Councilman Freda recusing himself from the vote.

Councilman Biront made a motion to approve the February 24, 2024 budget meeting minutes. The motion was seconded by Councilwoman Perrotti and approved by a 4-0 voice vote with Councilman Bardi and Councilman Freda recusing themselves from the vote.
