Councilwoman Fishman made a motion to approve Resolution No. 293-2023 Approval to Close to Executive Session to discuss the following:

The motion was seconded by Councilwoman Perrotti and approved by a 4-0 voice vote (Bardi, Freda absent). The public hearing will be held on October 17, 2023.

Councilwoman Fishman made a motion to introduce Ordinance No. 26-2023: "Ordinance amending Section 3(c) of Bond Ordinance No.06-2023 of the Borough of Roseland, in the County of Essex, New Jersey, finally adopted February 21, 2023, in order to amend the description in its's entirety". The motion was seconded by Councilwoman Perrotti and approved by a 4-0 voice vote (Bardi, Freda absent). The public hearing will be held on October 17, 2023.

Ordinance No. 27-2023 was withdrawn and replaced by Ordinance No. 28-2023 below.

Councilman Trillo made a motion to introduce Ordinance No. 28-2023: "Ordinance reappropriating \$1,365,943 aggregate proceeds of obligations not needed for their original purposes in order to provide for various water main replacements in and by the Borough of Roseland, in the County of Essex, New Jersey". The motion was seconded by Councilwoman Fishman and approved by a 4-0 voice vote (Bardi, Freda absent). The public hearing will be held on October 17, 2023.
