AN ORDINANCE OF THE BOROUGH OF ROSELAND TO REPEAL  
ORDINANCE NO. 16-2016 AS AMENDED WHICH PROVIDED FOR SALARIES  
AND COMPENSATION TO BE PAID TO NON-UNION EMPLOYEES OF THE  
BOROUGH OF ROSELAND AND SUBSTITUTE THEREFORE SALARIES AND  
COMPENSTATION FOR THE YEAR 2017

BE IT ORDAINED by the Mayor and Council of the Borough of Roseland, County of Essex, State  
of New Jersey as follows:

**SECTION III**


This ordinance shall take effect immediately upon its proper publication after passage in the manner provided by law, and all salary and remuneration provided herein shall be effective on January 1, 2017.


