AN ORDINANCE AMENDING CHAPTER IV OF THE  
REVISED GENERAL ORDINANCES OF THE BOROUGH OF  
ROSELAND ENTITLED "LICENSING AND BUSINESS  
REGULATIONS", CREATING NEW SECTION 4-12  
ENTITLED "LICENSE TO OPERATE FOOD AND/OR  
BEVERAGE VENDING MACHINES ON BOROUGH OWNED  
PROPERTY"

WHEREAS, the Mayor and Council of the Borough of Roseland wish to amend Chapter IV of the Revised General Ordinances of the Borough of Roseland entitled "Licensing and Business Regulations" to require licensing of food and/or beverage machines on borough owned property,

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Chapter IV of the Revised General Ordinances of the Borough of Roseland entitled "Licensing and Business Regulations" shall be amended as follows:

**SECTION I**

That Chapter IV entitled "Licensing and Business Regulations" shall be amended to add the following **thus** and to delete the following **thus**:

**4-12.1 License Required**

**a. In addition to the Health Department license required by section 4-9.1 above, and section BH:8-5 of the "Revised General Ordinances of the Board of Health of the Borough of Roseland", a separate Vending Machine License shall be required from the Borough Clerk to operate a Food and/or Beverage vending machine on Borough owned property.**

**4-12.2 Fee Required**

**a. In addition to the Health Department license fee required by section 4-9.3d. above, and section BH:8-10a.4. of the "Revised General Ordinances of the Board of Health of the**

**Borough of Roseland”, a separate Vending Machine License fee of two hundred and fifty dollars (\$250.00) shall be required for each vending machine on Borough owned property.**

**SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect in accordance with applicable law.




