

**ORDINANCE NO. 04-2019**

**BOROUGH OF ROSELAND  
COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER II OF THE REVISED  
GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND  
ENTITLED "ADMINISTRATION" TO ADD NEW SECTION 2-81  
ENTITLED "CITIZEN POLICE ACADEMY"**

**WHEREAS**, the Mayor and Council of the Borough of Roseland wish to amend Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration" to add a new Section 2-81 entitled "Citizen Police Academy";

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration" is hereby amended by adding new Section 2-81 entitled "Citizen Police Academy":

**SECTION I**

That Chapter II entitled "Administration" shall be amended to add the following new Section 2-81 entitled "Citizen Police Academy" as follows:

**CHAPTER II ADMINISTRATION**

**2-81 CITIZEN POLICE ACADEMY**

**2-81.1 Creation.**

The Borough of Roseland hereby establishes a Citizen Police Academy. The Citizen Police Academy is limited to twenty-five (25) members per session. Each session will consist of eight (8) weeks of classes. Applicants interested in applying for the Academy shall submit an application to the Roseland Police Department. Classes are open to residents of Roseland, Roseland Business Owners (on a limited basis), and Roseland Borough Employees (on a limited Basis) who are 18 years or older. Admission will be made on a first come, first serve basis.

The purpose of the Academy is to provide attendees with real training and knowledge about the Borough Police Department and to help bolster safety within the community of

Roseland. The classes offered through the Academy will provide an in-depth view of the various areas of law enforcement such as criminal investigations, firearms, use of force, officer safety, motor vehicle stops and advancements in technology utilized in law enforcement.

#### **2-81.2 Fee**

The fee for the Citizen Police Academy shall be \$100.00. This fee will be used to create a Roseland Citizen Police Academy Scholarship, which will be awarded to a Roseland student with plans to pursue a four (4) year degree. The scholarship winner will be selected by the Roseland Citizen Police Academy Executive Board.

#### **2-81.3 Roseland Citizen Police Academy Executive Board**

a. The Roseland Citizen Police Academy Executive Board shall consist of five (5) members, one of whom shall be the LEAD Officer within the Roseland Police Department and the remaining four (4) members shall be appointed by the Mayor, and shall serve at the pleasure of the Mayor, and shall be residents of the Borough. The Mayor shall designate one (1) of the members to serve as Chairperson and one (1) of the members to serve as Vice Chairperson. Members shall serve for a term of one (1) year.

b. The purpose of the Executive Board is to review each spring the scholarship applications received by the Borough of Roseland for the Roseland Citizen Police Academy Scholarship and to verify eligibility and to ultimately chose who the yearly scholarship should be awarded to.

#### **2-81.4 Compensation.**

The members of the Roseland Citizen Police Academy Executive Board shall receive no compensation for their services.

### **SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

### **SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect in accordance with applicable law.




