

ORDINANCE NO. 08-2015

**BOROUGH OF ROSELAND
COUNTY OF ESSEX, STATE OF NEW JERSEY**

AN ORDINANCE OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY, PROVIDING FOR A SUPPLEMENTAL APPROPRIATION OF \$40,000 TO COMPLETE THE BOROUGH'S RECONSTRUCTION OF MONROE AVENUE.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF ROSELAND, IN THE COUNTY OF ESSEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. On July 22, 2014, the Borough of Roseland, in the County of Essex (the "Borough") finally adopted Bond Ordinance 6-2014 (the "Prior Ordinance") for the purpose of reconstruction of Monroe Avenue, including base repairs as needed, full width milling and related improvements to curbing, curb ramps, striping and repairs to various structures within the roadway, as further set forth on a list on file for inspection in the Office of the Borough Clerk, and including all work and related materials necessary therefor and incidental thereto (the Project"). The Borough has determined that an additional \$40,000, in addition to the \$260,000 appropriated under the Prior Ordinance, is required to undertake the Project. There is hereby appropriated the sum of \$40,000 from the Borough's Capital Account for such purpose.

Section 2. The capital budget or temporary capital budget (as applicable) of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by

the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect as provided by law.


