AN ORDINANCE OF THE BOROUGH OF ROSELAND TO REPEAL
ORDINANCE NO. 03-2017 AS AMENDED WHICH PROVIDED FOR SALARIES
AND COMPENSATION TO BE PAID TO NON-UNION EMPLOYEES OF THE
BOROUGH OF ROSELAND AND SUBSTITUTE THEREFORE SALARIES AND
COMPENSTATION FOR THE YEAR 2018

BE IT ORDAINED by the Mayor and Council of the Borough of Roseland, County of Essex, State
of New Jersey as follows:


