ORDINANCE NO. 12-2015

BOROUGH OF ROSELAND COUNTY OF ESSEX, STATE OF NEW JERSEY

AN ORDINANCE AMENDING CHAPTER II OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND ENTITLED "ADMINISTRATION", AMENDING SECTION 2-33 ENTITLED "DIRECTOR OF RECREATION, PARKS AND PLAYGROUNDS" TO AMEND THE DUTIES OF THE RECREATION DIRECTOR

WHEREAS, Section 2-33.3, entitled "Duties", of Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration", establishes the duties of the Recreation Director; and

WHEREAS, the Mayor and Council of the Borough of Roseland wish to expand the duties of the Recreation Director to ensure Recreation Department compliance with Section 2-38 of the Revised General Ordinances of the Borough of Roseland entitled "Criminal History Background Checks for Employees and Volunteers of Nonprofit Youth Servicing Organization[s] and/or Employees and Volunteers Involved with Borough Sponsored Programs or Services for Minors";

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Borough of Roseland that Section 2-33.3, entitled "Duties", of Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration", shall be amended as follows:

SECTION I

That section 2-33.3, entitled "Duties" shall be amended to add the following **thus** and to delete the following **thus**:

2-33.3 Duties.

- a. o. No change.
- **p.r.** Change paragraph "p." to "r." and insert new paragraphs "p." and "q." as follows:
- <u>p.</u> <u>Be responsible for compliance with Section 2-38.</u>
- <u>Q.</u> Ensure compliance with Section 2-38. and ensure that all Recreation Department activities involving minors, including co-sponsored activities, are supervised by at least two adults at all times.
- **<u>r.</u>** Perform such other duties as may be assigned to him by the Borough Council.

SECTION II

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

SECTION III

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

This ordinance shall take effect upon publication as provided by law.
