

**ORDINANCE NO. 13-2018**

**BOROUGH OF ROSELAND**

**COUNTY OF ESSEX, STATE OF NEW JERSEY**

**AN ORDINANCE AMENDING CHAPTER XIII OF THE REVISED  
GENERAL ORDINANCES OF THE BOROUGH OF ROSELAND  
ENTITLED "FIRE PREVENTION AND PROTECTION"**

**WHEREAS**, the Mayor and Council of the Borough of Roseland wish to amend Chapter XIII of the Revised General Ordinances of the Borough of Roseland entitled "Fire Prevention and Protection"; Section 13-1.7 entitled "Permit Fees", and

**WHEREAS**, the Roseland Fire Official has recommended that the local fire prevention permit fees be increased to the same amount as the NJ Division of Fire Safety permit fees;

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that Chapter XIII of the Revised General Ordinances of the Borough of Roseland entitled "Fire Prevention and Protection"; Section 13-1.7 entitled "Permit Fees" shall be amended as follows:

**SECTION I**

That section 13-1.7, entitled "Permit Fees" shall be amended to add the following **thus** and to delete the following **thus**:

**13-1.7 Permit Fees.**

Type 1	<del>\$52.00</del>	<u>\$62.00</u>
Type 2	<del>\$176.00</del>	<u>\$225.00</u>
Type 3	<del>\$350.00</del>	<u>\$440.00</u>
Type 4	<del>\$500.00</del>	<u>\$650.00</u>

Permits are further required to be obtained from the Bureau of Fire Prevention for the following activities at the amount specified for each herein:

- a. No change
- b. No change
- c. No change
- d. No change

**SECTION II**

If any section of provision of this ordinance shall be invalid in any court the same shall not affect the other sections or provisions of this ordinance except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION IV**

This ordinance shall take effect in accordance with applicable law.




