AWARD OF BID TO AMERICAN ASPHALT AND MILLING  
SERVICES LLC FOR THE LOCUST AVENUE ROAD  
IMPROVEMENT PROJECT FOR \$178,874.30

**WHEREAS**, the Borough of Roseland has a need to improve the road of Locust Avenue;  
and

**WHEREAS**, the Borough of Roseland received and opened six separate sealed bids on  
Wednesday, March 14, 2018; and

**WHEREAS**, American Asphalt and Milling Services LLC of 96 Midland Avenue, Kearny,  
NJ 07032 submitted the lowest qualified bid in the amount of \$178,874.30 which includes both  
the base bid for \$153,510.69 and alternate bid "A" for \$25,363.61; and

**WHEREAS**, bids were reviewed by the Superintendent of Public Works, Borough Clerk  
and Borough Engineer and found it to be responsive and responsible; and

**WHEREAS**, Pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has  
certified funds are available from Capital Improvement Fund 5-2017 in the amount of 158,102.73  
(C-04-55-917-005) and the Capital Improvement Fund 6-2017 in the amount of \$20,771.57 (C-  
04-55-917-006) under PO 18-00506;


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of

the Clerk of the Borough of Roseland; and


