AWARD OF NON-FAIR AND OPEN CONTRACT TO
S. RONTONDI & SONS INC. FOR TUB GRINDING,
HAULING AND DISPOSAL SERVICES FOR TREE DEBRIS
COLLECTED FROM THE MARCH 7TH – 8TH SNOW STORM

WHEREAS, Resolution No. 11-2018 establishes an expense limit for Department Heads and authorizes expenditures of not more than 15% of the bid threshold per purchase without the prior Council approval; and

WHEREAS, the Department of Public Works has a need to acquire tub grinding, hauling and disposal services for tree debris collected from the March 7th & 8th snowstorm as a non-fair and open contract pursuant to the provisions of N.J.S.A. 40A:11-5. and in accordance with the Pay-to-Play provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Chief Financial Officer and Purchasing Agent have determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, quotes were solicited pursuant to N.J.S.A. 40A:11-6.1 and four written quotes were received, with S. Rotondi & Sons, LLC , PO Box 1407, Summit, NJ 07902 submitting the lowest qualified quote in the amount of \$7,000.00 per day, for an amount not to exceed of \$28,000.00; and

WHEREAS, S. Rotondi & Sons LLC has completed and submitted a Business Entity Disclosure Certification which certifies that S. Rotondi & Sons, LLC has not made any reportable contributions to a political or candidate committee in the Borough of Roseland in the previous one year, and that the contract will prohibit S. Rotondi & Sons, LLC from making any reportable contributions through the term of the contract, and


WHEREAS, pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified that funds in the amount of \$28,000.000 are available under Purchase Order #18-00544 and charged to Trust Fund Account T-12-56-850-326;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Borough of Roseland hereby authorize the Borough to enter into a contract with S. Rotondi & Sons, LLC for services as described herein; and


BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution.
