

RESOLUTION NO. 190-2018

INTERLOCAL AGREEMENT BETWEEN THE BOROUGH OF ROSELAND AND THE  
TOWNSHIP OF WEST ORANGE FOR ANIMAL CONTROL SERVICES

**WHEREAS**, the Borough of Roseland and Township of West Orange are renewing an Inter-Local Agreement whereby certain animal control services shall be provided for a two (2) year period from July 1, 2018 to June 30, 2020; and

**WHEREAS**, Roseland will pay West Orange the sum of \$14,121.80 per annum to be prorated on a quarterly basis of \$3,530.45 per quarter and paid within thirty (30) days of receipt of invoice for the contract year 2018-2019, and the sum of \$14,827.91 per annum to be prorated on a quarterly basis of \$3,706.98 per quarter and paid within thirty (30) days of receipt of invoice for the contract year 2019-2020; and

**WHEREAS**, pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$7,060.90 under PO 18-00512 and charged \$6,405.32 to Budget Account 8-01-42-340-205 and \$655.58 to A-20-56-852-856;

**WHEREAS**, Pursuant to N.J.S.A 40A:11-15 funds for future years are subject to the availability of sufficient funds; and

**WHEREAS**, the Borough of Roseland shall indemnify the Township of West Orange for any services provided for the Borough of Roseland and the Agreement shall permit either party to terminate on sixty (60) days written notice.


**NOW THEREFORE BE IT RESOLVED**, by the Borough Council of the Borough of Roseland that the attached Inter-Local Agreement with the Township of West Orange concerning certain animal control services be and is hereby approved; and

**BE IT FURTHER RESOLVED**, that the Mayor be and is hereby authorized to execute and the Municipal Clerk is authorized to attest to the Mayor's signature; and


**BE IT FURTHER RESOLVED** that this Resolution shall be advertised in accordance with applicable law and the Agreement maintained in the Municipal Clerk's permanent files.
