AWARD CONTRACT TO ATLANTIC SWITCH & GENERATOR LLC FOR
 GENERATOR MAINTENANCE AND EMERGENCY REPAIRS THROUGH
 MORRIS COUNTY CO-OP

WHEREAS, the Borough of Roseland has a need for generator maintenance and emergency repairs services;
 and

WHEREAS, the Borough of Roseland, pursuant to N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the Morris County Cooperative Pricing Program (MCCPC) for any MCCPC contracts entered into on behalf of the Morris County Cooperative Pricing Council; and

WHEREAS, Atlantic Switch & Generator LLC with an office at 4108 Sylon Boulevard, Hainesport, NJ 08036 was awarded Contract 46 through Morris County Co-Op for generator maintenance and emergency repairs from July 1, 2017 through June 30, 2019; and

WHEREAS, the Borough of Roseland intends to enter contracts with the Atlantic Switch & Generator LLC from June 8, 2018 through June 30, 2019 for generator maintenance and emergency repairs; and

WHEREAS, Pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$16,400.00 for the calendar year 2018 and charged to the following accounts:


\$10,900.00 under PO 18-00692 and charged to budget account 8-09-55-500-181
 \$5,500.00 under PO 18-00693 and charged to budget account 8-01-26-310-181


WHEREAS, Pursuant to N.J.S.A 40A:11-15 funds for future years are subject to the availability of sufficient funds; and
