AWARD UNLEADED GASOLINE FUEL DELIVERY CONTRACT TO  
ALLIED OIL, LLC THROUGH MORRIS COUNTY CO-OP CONTRACT #1  
TO REFLECT OWNERSHIP NAME CHANGE TO GRIFFITH-ALLIED TRUCKING LLC

**WHEREAS**, Resolution 173-2018 awarded Morris County Co-Op Contract #1 to Allied Oil LLC to deliver unleaded gasoline for the contract period of May 16, 2018 through December 31, 2019; and

**WHEREAS**, effective May 22, 2018 Griffith-Allied Trucking, LLC purchased the operations of Allied Oil, LLC from Oxford Development and will now be operating as Griffith-Allied Trucking DBA Allied Oil; and

**WHEREAS**, on June 2, 2018 the Borough of Roseland was notified the MCCPC has approved the assignment of the contracts to Griffith-Allied for the contract period of Co-Op Contract for a contract period of January 25, 2018 through December 31, 2019;


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that they approve the MCCPC Contract #1 to Griffith-Allied Trucking, LLC, for the aforementioned services. All other provisions MCCPC awarded on January 25, 2018 shall remain in full force and effect; and


**BE IT FURTHER RESOLVED** that Griffith-Allied Trucking, LLC will charge \$0.1275 for premium unleaded gasoline fuel and will make deliveries twice a month. The total contract shall not exceed \$100,000.00 without prior written consent of the governing body; and

**BE IT FURTHER RESOLVED** a copy of this resolution as well as the contract shall be placed on file with the Clerk of the Borough of Roseland.
