AMENDING RESOLUTION 221-2017 APPROVAL OF CONTRACT EXTENTION WITH W. W. GRAINGER INC. FOR INDUSTRIAL/MRO SUPPLIES & EQUIPMENT UNDER NEW JERSEY STATE CONTRACT A79875 AND AUTHORIZING THE FOURTH EXTENSION FROM JULY 1, 2018 TO SEPTEMBER 30, 2018

WHEREAS, the Borough of Roseland has a need to purchase Industrial/MRO Supplies and Equipment; and

WHEREAS, W. W. Grainger Inc was awarded the NJ State Contract #A79875 for Industrial/MRO Supplies and Equipment for contract period September 14, 2011 to February 28, 2014; and

WHEREAS, W.W. Grainger Inc. was granted a three year extension from March 1, 2014 through February 28, 2017; and

WHEREAS, Resolution 112-2014 authorized the Contract between the Borough of Roseland and W.W Granger Inc. for Industrial/MRO Supplies and Equipment from March 1, 2014 through February 28, 2017; and

WHEREAS, March 28, 2017 the Borough passed Resolution 124-2017 extending the contract through Amendment #2-Contract Extension for the term of March 1, 2017 to June 30, 2017 and

WHEREAS, July 18, 2017 the Borough passed Resolution 221-2017 extending the contract through Amendment #3-Contract Extension for the term of July 1, 2017 to June 30, 2018 and


WHEREAS, the Borough wishes to extend the contract through amendment #4-Contract extension July 1, 2018 to September 30, 2018; and

WHEREAS, W. W. Grainger, Grainger Industrial Supply Div, Government Call Center, 101 Hadley Road, South Plainfield, NJ 07080 has agreed to supply industrial/MRO Supplies and Equipment to the Borough of Roseland as per the attached NJ State Contract #A79875, and

WHEREAS, the Chief Financial Officer will certify availability of funds through a properly executed purchase order.


