AUTHORIZING THE MAYOR AND BOROUGH CLERK TO  
EXECUTE A RENEWED SHARED SERVICES AGREEMENT WITH  
THE TOWNSHIP OF VERONA TO PROVIDE CONSTRUCTION  
OFFICIAL, SUB-CODE OFFICIAL AND INSPECTION SERVICES

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the "Act"), authorized local units of this State to enter into agreements with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

**WHEREAS**, the Borough of Roseland has previously entered into a Shared Services Agreement to provide Construction Official, Sub-Code Official and Inspection services with the Township of Verona which expired on December 31, 2017; and

**WHEREAS**, the Borough of Roseland and the Township of Verona are desirous to renew the Shared Services agreement to continue to provide Construction Official, Sub-Code Official and Inspection services during 2018; and


**WHEREAS**, the Borough of Roseland and the Township of Verona have reached an agreement as to the terms and conditions associated with said agreement; and

**WHEREAS**, it is in the best interest of both municipalities to renew this Shared Services Agreement for the period beginning January 1, 2018 and terminating December 31, 2018; and


**WHEREAS**, pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$127,293.00 under PO 18-00754 and charged to Budget Account 8-01-42-195-150;

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland, in the County of Essex, New Jersey that the Mayor and Borough Clerk are hereby authorized to execute a Shared Services Agreement with the Township of Verona to provide Construction Official, Sub-Code Official and Inspection services.
