AUTHORIZING THE EXTENTION OF STATE CONTRACT #A-80914 TO ALLIED OIL, LLC, INC FOR THE PURCHASE OF UNLEADED FUEL FROM DECEMBER 1, 2017 THROUGH FEBRURARY 28, 2018

**WHEREAS**, the Borough of Roseland entered into a contract with Allied Oil, LLC P.O. Box 392, Manville, NJ 08835 under State Contract #A-80914 for a contract period of January 1, 2015 to December 31, 2015 as per resolution 87-2015 for the delivery of unleaded fuel; and

**WHEREAS**, the State of New Jersey has amended State Contract #A-80914 for a sixth extension exercised under the contract for a period beginning November 30, 2017 to February 28, 2018; and

**WHEREAS**, the Borough of Roseland has a desire extend the contract with Allied Oil, LLC. Inc. under state contract #A-80914 for the contract period of December 1, 2017 to February 28, 2018; and

**WHEREAS**, the additional cost for the extension of the contract shall not exceed \$8,000.00 without written consent of the Mayor and Council; and

**WHEREAS**, pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$8,000.00 under PO 18-00011 and charged to budget account 8-01-31-460-083;and

**WHEREAS**, N.J.A.C. 5:30-5.5(e) permits contracts to be awarded for the next fiscal year subject to the availability and appropriation of sufficient funds in the year in which it takes effect; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 funds for future years are subject to the availability of sufficient funds;

**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that they approve the extension of State Contract #A-80914 to Allied Oil, LLC. Inc. for the aforementioned services. All other provisions State Contract #A-80914 awarded on shall remain in full force and effect; and

**BE IT FURTHER RESOLVED** a copy of this resolution as well as the contract shall be placed on file with the Clerk of the Borough of Roseland; and


**BE IT FURTHER RESOLVED** that the terms and conditions of Resolution No. 87-2015 apply.
