**AUTHORIZING CANCELLATIONS OF WATER SEWER  
 BILLINGS-BALANCES**

**WHEREAS**, there appears on the official water sewer billing records an incorrect billing as shown below; and

**WHEREAS**, when it has been determined by the Water Sewer Division that the high consumption was due to a leak, the total consumption used shall be billed at \$4.57 per thousand;

**WHEREAS**, when it has been determined by the Water Sewer Division that the high consumption was caused by an error in recording the meter reading or the inability to obtain a read, the total consumption used shall be billed at \$3.50 per thousand;


