AMEND RESOLUTION NO. 70-2017 "AWARD OF QUOTE FOR  
 GENERAL PLUMBING REPAIRS THROUGHOUT THE BOROUGH  
 FOR THE CALENDAR YEAR 2017" TO INCREASE THE NOT TO  
 EXCEED AMOUNT

**WHEREAS**, Russo Brothers was awarded the quote for Plumbing Repairs for 2017 on February 7, 2017 by Resolution No. 70-2017; and

**WHEREAS**, Resolution No. 70-2017 stipulated the amount not to exceed the sum of \$7,500.00 in the aggregate for services rendered without written approval of the Mayor and Council; and

**WHEREAS**, add-on services in the amount of \$3,983.25 were required due to emergency plumbing repairs done at the 19 and 15 Harrison Avenue Municipal Building, requiring an increase in the maximum amount not to exceed to \$11,483.25 for the aforementioned services, and


**WHEREAS**, pursuant to N.J.A.C. 5:30-5.4 the Chief Financial Officer has certified there are sufficient funds in the amount of \$5,027.20 under Purchase Order 17-00230 and charged to account 7-01-26-310-061; and


**WHEREAS**, the not to exceed amount may not be increased without written prior approval of the Mayor and Council.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Roseland that they approve the not to exceed amount to be increased from \$7,500.00 to \$11,483.25 for the aforementioned services. All other provisions of Resolution No. 70-2017 shall remain in full force and effect.
