BOROUGH OF ROSELAND

AUTHORIZING THE APPOINTMENT OF REMINGTON, VERNICK &
ARANGO ENGINEERS AS THE WATER AND SEWER ENGINEER IN
ACCORDANCE WITH N.J.S.A 19:44A-20.5

WHEREAS, the Borough of Roseland has a need to acquire services of an engineer to annually evaluate the Borough's water and sewer systems; and

WHEREAS, the Borough of Roseland is desirous of obtaining the most qualified professional services and the most competitive pricing regarding those professional services; and

WHEREAS, Professional Services are exempt from Public Bidding; and

WHEREAS, the Borough of Roseland utilized the Fair and Open Process set forth in N.J.S.A. 19:44A-20.5 to solicit proposals from qualified professionals; and

WHEREAS, on October 19, 2017 the Borough of Roseland solicited for Request for Proposals for Engineering Services and bids were opened on December 6, 2017; and

WHEREAS, proposals were received from JMH Associates, Remington, Vernick & Arango Engineers, Maser Consulting, PA, Bright View Engineering, and Petry Engineering; and

WHEREAS, the firm of Remington, Vernick & Arango Engineers was awarded a contract in 2016 to perform an evaluation of the Borough's water and sewer infrastructure, and to develop recommendations for long term improvements to the Borough's water and sewer infrastructure; and

WHEREAS, the governing body wishes to continue to use the services of Remington, Vernick & Arango for all Water and Sewer System projects; and

WHEREAS, the anticipated term of this contract is for a period of time commencing January 1, 2018 ending on December 31, 2018; and

WHEREAS, Pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$45,000.00 under P.O. 18-00281 and charged to Budget Account 8-09-55-500-086;


NOW, THEREFORE, BE IT RESOLVED that the Borough of Roseland authorizes Mayor John Duthie to enter into a contract with Remington, Vernick & Arango Engineers, 300 Penhorn Avenue, 3rd Floor, Secaucus, NJ 07094 in accordance with the terms and as described in this Resolution, which Contract is to be in a form that is approved by the Borough Attorney; and

BE IT FURTHER RESOLVED that a copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Roseland; and


