WHEREAS, Professional Services are exempt from Public Bidding; and

WHEREAS, on October 19, 2017 the Borough solicited Requests for Proposals and RFP's were received on December 6, 2017; and

WHEREAS, one proposal was received from the firm of Campbell Petrie, Inc.,

WHEREAS, the Borough of Roseland received proposals through the fair and open process; and

WHEREAS, there is no fee charged directly to the Borough; and

WHEREAS, Campbell Petrie, Inc. will receive the standard commission structure that is built in by the carrier and will supply the Borough with a commission schedule from chosen carrier for full discloser; and

WHEREAS, Campbell Petrie, Inc. has also disclosed that they accept carrier bonuses and should any arise as a result to the product Campbell Petrie will disclose information to the Borough

WHEREAS, the anticipated term of this contract is for a period of time commencing January 1, 2018 through December 31, 2018; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Roseland that Mayor John Duthie is hereby authorized and directed to enter into a Contract, on behalf of the Borough of Roseland with Campbell Petrie, Inc. as the Borough of Roseland Employee Benefit Broker of Record and Consulting Services.
