AUTHORIZING THE APPOINTMENT OF BRIGHT VIEW ENGINEERS AS
THE TRAFFIC ENGINEER IN ACCORDANCE WITH N.J.S.A 19:44A-20.5

WHEREAS, the Borough of Roseland has a need to acquire services of an engineer for the traffic services; and

WHEREAS, the Borough of Roseland is desirous of obtaining the most qualified professional services and the most competitive pricing regarding those professional services; and

WHEREAS, Professional Services are exempt from Public Bidding; and

WHEREAS, the Borough of Roseland utilized the Fair and Open Process set forth in N.J.S.A. 19:44A-20.5 to solicit proposals from qualified professionals; and

WHEREAS, on October 19, 2017 the Borough of Roseland solicited for Request for Proposals for Engineering Services and bids were opened on December 6, 2017; and

WHEREAS, proposals were received from JMH Associates, Remington Vernick & Arango Engineers, Maser Consulting, PA, Bright View Engineering and Petry Engineering; and

WHEREAS, the scope of work for each capital/infrastructure project will be established based on review with the governing body and municipal staff; and

WHEREAS, the fees for each project will be presented in proposal form with established lump sum and certification of funds will be ascertained at that time, and

WHEREAS, the anticipated term of this contract is for a period of time commencing January 1, 2018 ending on December 31, 2018; and



BE IT FURTHER RESOLVED that a copy of this resolution as well as the Contract shall be placed on file with the Clerk of the Borough of Roseland; and


