AWARDING STATE CONTRACT FOR TIRES, TUBES AND
SERVICES TO INCLUDE BRIDGESTONE AMERICAS INC.
STATE CONTRACT NO. 82528

WHEREAS, on March 28, 2017 the governing body awarded a two-year contract for tires, tubes and services to Good Year Tire and Rubber Co. under state contract #82527; and

WHEREAS, the Department of Public Works has the need to include Bridgestone Americas, Inc. State Contract #A82528; and

WHEREAS, the State has extended the State contract for a Second Extension to begin April 1, 2017 to March 31, 2019; and

WHEREAS, Custom Bandag, 401 E. Linden Avenue, Linden, NJ 07036 is and authorized dealer for State Contract #A82527 and A82528; and

WHEREAS, Custom Bandag, 401 E. Linden Avenue, Linden, NJ 07036 has agreed to supply tires, tubes and services to the Borough of Roseland as per the terms and conditions of NJ State Contract #A82528 for the period April 1, 2017 to March 31, 2019; and

WHEREAS, the estimated cost of tires, tubes and services for the contract period of April 1, 2017 to March 31, 2019 shall not exceed \$15,000.00 without prior written consent of the governing body; and

WHEREAS, pursuant to N.J.A.C. 5:30-5.4 et seq., the Chief Financial Officer has certified funds in the amount of \$1,610.00 under PO 18-00325 and charged to the Budget Account Number 8-01-26-315-290 through April 1, 2018; and

WHEREAS, the Chief Financial Officer will certify availability of funds for additional purchases during the calendar year by approving a properly executed purchase order; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 funds for future years are subject to the availability of sufficient funds.




