#### COUNCIL MEETING MINUTES

### CALL TO ORDER & SUNSHINE STATEMENT

The April 17, 2018 Meeting of the Roseland Mayor and Council was called to order at 6:30 PM by Mayor Duthie. Adequate notice of the meeting was provided in accordance with the Open Public Meeting Act in that the date, time and location of the meeting was sent to the official newspapers, posted on the public bulletin board in the Municipal Building and filed in the office of the Borough Clerk.

#### **EXECUTIVE SESSION**

Borough Attorney Sheffet read Resolution No. 134-2018 Approval to Close to Executive Session to discuss the following:

Councilman Jacobs made a motion to approve the Resolution at 6:31 PM. The motion was seconded by Councilwoman Tolli and approved by a 5-0 voice vote (Mr. Tsilionis arrived after vote).

Councilman Jacobs made a motion to close Executive Session and to return open session at 7:26 PM. The motion was seconded by Councilman Smith and approved by a 6-0 voice vote. ### **PUBLIC HEARING & ADOPTION OF ORDINANCES**

Councilman Smith made a motion to open the public hearing on Ordinance No. 05-2018. Councilman Jacobs seconded the motion and the motion was approved by a 6-0 voice vote.

Prior to accepting public comment on the ordinance, Financial Advisor Dan Mariniello of NW Financial Group and Redevelopment Attorney Bill Northgrave explained the details of the proposed financial agreement and the next steps in the redevelopment process should this ordinance be adopted. Throughout the hearing, Mr. Mariniello and Mr. Northgrave responded to questions from the public and the governing body.

Councilman Bardi seconded the motion and the motion was approved by a 6-0 voice vote, with Councilman Leonard voting against Resolution No. 137-2018, Resolution No. 148-2018, and Resolution No. 149-2018; and abstaining from the vote on Resolution No. 141-2018.

### **MAYOR'S REPORT**

Mayor Duthie reported that local contractor Thomas O'Beirne has volunteer his company to repair the stone wall at the Roseland Library. Mayor Duthie invited anyone who is interested in volunteering to assist with the repair to contact the municipal offices.

### **COMMITTEE REPORTS**

### PUBLIC WORKS

Councilman Smith thanked residents for their understanding of the difficulties that Council was faced with regarding the Court imposed development leading up to the approval of the two financial agreements tonight. Mr. Smith also thanked the Borough's professionals on these projects, Mr. Northgrave and Mr. Mariniello, and Borough Attorney Sheffet.

### **PUBLIC SAFETY**

With the resignation of the remaining members of the Shade Tree Commission, Councilman Jacobs asked that the Department of Public Works check the condition of trees, identified by ribbons, which may be overhanging the street and utility lines in the woods on the Borough property on Woodland Avenue. Mr. Jacobs also urged residents not to speed on streets within the Borough, noting that speeding tickets are being issued in town and there have been a number of motor vehicle accidents.

Councilman Jacobs made a motion to grant permission to Mr. Christopher DeMarco to remove a tree on his property at 14 Evergreen Place at his own expense. The motion was seconded by Councilman Smith and approved by a 6-0 voice vote.

Councilman Jacobs made a motion to approve Resolution No. 151-2018 authorizing the purchase of four (4) portable radios and related equipment for the use of the Police Department under State Contract #83932 from North East Communications at a cost of eighteen thousand three hundred and forty-six dollars (\$18,346.00). The motion was seconded by Councilman Smith and approved by a 6-0 voice vote.

Councilman Jacobs made a motion to approve Resolution No. 150-2018 authorizing to pre-pay five hundred sixty-eight thousand eight hundred dollars (\$568,800.00) to Pierce Manufacturing for the purchase of a fire truck apparatus resulting in the reduction of the contract price by eighteen thousand four hundred and eighty dollars (\$18,480.00). The motion was seconded by Councilman Leonard and approved by a 6-0 voice vote.

### **RECREATION**

Councilwoman Tolli announced that opening day baseball and the annual parade will be held this coming Saturday, April 21<sup>st</sup>, at Bond Force Park. Mrs. Tolli informed residents that the deadline for submission of nominations for Mother of the Year are due by Friday, April 27<sup>th</sup>. Councilwoman Tolli reported that the annual Running 4 Answers 5K Race to benefit the Cure Alzheimer's Fund will take place on Saturday April 28<sup>th</sup> at Harrison Field. Mrs. Tolli stated that there is still one opening on the Senior Transportation Committee. The Committee's next meeting will be held at the Caldwell Community Center on May 7<sup>th</sup> at 6:15 PM. Mrs. Tolli advised that the Beautification Committee will be planting flowers around town as soon as the weather breaks.

Councilwoman Tolli made a motion to authorize advertising for a part-time secretary for the Recreation Department. The motion was seconded by Councilman Bardi and approved by a 6-0 voice vote.

#### CAPITAL IMPROVEMENTS

Councilman Leonard reported that the Borough's Traffic Engineer met recently with Administrator Chumacas to review safety recommendations previously discussed by Council. Mr. Leonard added that he expects recommendations from the engineer to be forthcoming. Councilman Leonard stated that he attended the Fire Department's recent awards banquet noting that Tom Reed was honored for his daytime attendance, Eric Rasmussen was honored for ten years of service, and George Batta was honored for 52 years of service. Councilman Leonard announced that Chipotle's in West Caldwell will donate 50% of their proceeds between 4:00 PM and 8:00 PM on April 24<sup>th</sup> to the Roseland First Aid Squad when the patron mentions the Roseland First Aid Squad when ordering.

#### **PUBLIC AFFAIRS**

Councilman Bardi explained the resolution that was adopted tonight appointing members to the Compressor Station Ad Hoc Committee. Mr. Bardi announced that the Governing Body is teaming with the Sierra Club, Residents Against the Compressor Station (RACS), and a couple of other groups to oppose the proposed expansion of the compressor station on Eagle Rock Avenue. Mr. Bardi also mentioned that there are openings for four resident volunteers to serve on the committee. Anyone interested in serving should contact Councilman Bardi, Administrator Chumacas, or Clerk Watkins.

Administrator Chumacas reported that the draft newsletter has been circulated to Council and that the estimated cost to print and mail will not exceed three thousand five hundred dollars (\$3,500.00). After discussion, Councilman Bardi made a motion to send the newsletter now, rather than wait for additional content. The motion was seconded by Councilman Tsilionis and approved by a 6-0 voice vote.

#### ADMINISTRATION & FINANCE

Councilman Tsilionis reported that the 2018 Municipal Budget introduction and public hearing will take place at the May 1<sup>st</sup> caucus meeting. The meeting will be held in the Public Meeting room at 19 Harrison Avenue and the meeting will be televised.

Councilman Tsilionis made a motion to make TAPInto West Essex the official electronic newspaper for the Borough. The motion was seconded by Councilman Jacobs and approved by a 6-0 voice vote.

Councilman Tsilionis made a motion to approve Resolution No. 152-2018 granting Sanctioned Status to Non-Profit Organizations that Maximize Recreational, Educational and Cultural Opportunities for Residents. The motion was seconded by Councilman Jacobs and approved by a 6-0 voice vote.
