### CALL TO ORDER & SUNSHINE STATEMENT

#### PUBLIC COMMENT

Councilman Leonard made a motion to delay closing to Executive Session in order to allow public comment from a former Councilman. The motion was seconded by Councilman Smith and approved by a 5-0 voice vote (Tsilionis absent).

Councilman Jacobs made a motion at 6:55 PM to approve the motion. The motion was seconded by Councilman Bardi and approved by a 6-0 voice vote.

Councilman Jacobs made a motion to close Executive Session and to return open session at 7:28 PM. The motion was seconded by Councilman Tsilionis and approved by a 6-0 voice vote. Mayor Duthie read the Sunshine Statement again at 7:30 PM and called the public meeting to order. Clerk Watkins called the roll with there being no changes.

### **INTRODUCTION OF ORDINANCES**

Clerk Watkins read <u>Ordinance No. 02-2018</u> for the first time: "An ordinance amending Chapter XIX of the Revised General Ordinances of the Borough of Roseland entitled

"Streets and Sidewalks". Councilman Tsilionis made a motion to introduce Ordinance No. 02-2018. The motion was seconded by Councilman Bardi and approved by a 5-0 voice vote with Councilman Jacobs abstaining because the ordinance impacts the development that he resides in. The Public Hearing on the ordinance will be held on March 13, 2018.

### **PUBLIC HEARING & ADOPTION OF ORDINANCES**

Clerk Watkins read <u>Ordinance No. 01-2018</u> for the second time: "An ordinance amending Chapter II of the Revised General Ordinances of the Borough of Roseland entitled "Administration, Section 2-24 entitled "Department of Police or Police Department". Councilwoman Tolli made a motion to open the public hearing on Ordinance No. 01-2018. Councilman Smith seconded the motion and the motion was approved by a 6-0 voice vote.

Councilman Smith made a motion to adopt Ordinance No. 01-2018. The motion was seconded by Councilman Tsilionis and approved by a 6-0 roll call vote.

Clerk Watkins read <u>Ordinance No. 03-2018</u> for the second time: "An ordinance amending Chapter XVII of the Revised General Ordinances of the Borough of Roseland entitled "Water and Sewer". Councilman Smith made a motion to open the public hearing on Ordinance No. 03-2018. Councilman Bardi seconded the motion and the motion was approved by a 6-0 voice vote.

There being no one wishing to be heard, Councilman Tsilionis made a motion to close the public hearing. The motion was seconded by Councilman Bardi and approved by a 6-0 voice vote.

After discussion, Councilman Smith made a motion to amend the ordinance and to advertise another public hearing to be held at the March 13<sup>th</sup> meeting:

- Add the wording "Failure to comply with this paragraph shall result in the commercial user being billed at a rate during that quarter that correlates to the highest amount of

consumption in the commercial user's past four quarters." to the end of renumbered paragraph 5.

The motion was seconded by Councilman Jacobs and approved by a 6-0 voice vote.

### **MAYORAL APPOINTMENT**

Councilman Smith made a motion for Council to consent to the Mayor's appointment of Katy Boettinger to the Affordable Housing Board to fill the unexpired term of William Tedesco through 12/31/18. The motion was seconded by Councilwoman Tolli and approved by a 6-0 voice vote.

### **MAYOR'S REPORT**

### **COMMITTEE REPORTS**

#### PUBLIC WORKS

Councilman Smith commended the Public Works Department for their continued good work.

### **PUBLIC SAFETY**

Councilman Jacobs reported that the construction of the new fire department ladder truck is proceeding on schedule noting that the truck should be ready in approximately twelve months. Mr. Jacobs added that he expects to have a report available at the next meeting on the proposed upgrades to the Borough's phone system. Councilman Jacobs also reported that in response to recent concerns, the Police Department will be continuing their effort to enforce speed limits and the prohibition of cell phone usage while driving a vehicle.

#### RECREATION

Councilwoman Tolli announced that there is one opening on the Beautification Committee and one opening on the Senior Transportation Committee. Mrs. Tolli asked Public Safety Chairman Jacobs to advise the police chief that the pedestrian crossing button on Eagle Rock Avenue is still missing.

After discussion, Council sent the matter of exception from background checks required for volunteers over the age of 18 for certain Boards or Committees back to Committee for a more complete recommendation.

After discussion, Council recommended that the permit application for use of Borough facilities be amended to include use of the meeting room at the Roseland First Aid Squad (RFAS) Building, and that the current policy regarding issuance of such permits be applied to use of the RFAS meeting room.

#### **CAPITAL IMPROVEMENTS**

Councilman Leonard commended the Department of Public Works, the Police Department, and Borough residents for their coordinated efforts to keep the town safe during the recent snow storm. Councilman Leonard commented on the sad comparison of television events on Valentine's Day noting the happy events involving the Winter Olympics and the sad events involving the school shooting in Parkland Florida.

### PUBLIC AFFAIRS

Councilman Bardi announced that Council has scheduled a special meeting on Thursday, January 30<sup>th</sup> to discuss the Borough's intervention in the Williams Transco Gateway Expansion Project Application currently before the Federal Energy Commission. Mr. Bardi also announced that the Borough will be mailing out a community newsletter with a target date in April.

### **ADMINISTRATION & FINANCE**

Councilman Tsilionis announced that there will be a budget meeting on Saturday, February 24<sup>th</sup> at 9:30 AM in the 2<sup>nd</sup> floor conference room at 140 Eagle Rock Avenue and invited anyone interested to attend. Mr. Tsilionis reported that the Borough's application to be an intervenor in the Williams Transco Gateway Expansion Project application has been granted. In response to Mayor Duthie's request for volunteers to serve on the Ad Hoc Committee formed earlier in the meeting, Councilman Bardi, Jacobs, and Leonard all agreed to serve on the Committee. Councilman Tsilionis suggested that the Borough's tax appeal experts attend the March 6<sup>th</sup> meeting. After discussion, Council agree to invite the tax appeal professionals to attend the March 6<sup>th</sup> Executive Session meeting.

#### APPROVAL OF MINUTES

Councilman Bardi asked that the February 6, 2018 Caucus Meeting Minutes be amended to reflect that "Mr. Bardi discussed possible changes to the calendar on the Borough's website <u>including adding the recycling days</u>." Councilman Jacobs made a motion to approve the amended February 6, 2018 Caucus Meeting Minutes. The motion was seconded by Councilwoman Tolli and approved by a 6-0 voice vote.
