Due to the ongoing Coronavirus (COVID-19) emergency, the August 18, 2020 meeting of the Roseland Mayor and Council was called to order at 6:30 PM via teleconference by Mayor Spango. #### SALUTE TO THE FLAG

#### **PRESENTATION**

Councilman Bardi displayed a PowerPoint presentation summarizing the final tax bill:

Amount to be raised by taxation  $\frac{\$9,943,241.25}{\$1,661,366,715}$  X 100 = .599%

For an average home assessed at \$466,970, the 2020 municipal tax increase will be \$17.29, and the total 2020 tax increase, including local school, regional school, County, Library, open space, and municipal will be \$97.23.

The motion was seconded by Councilwoman Fishman and approved by a 6-0 voice vote.

# CONSENT AGENDA

Councilman Trillo made a motion to approve the one item on the Consent Agenda:

Accept with Regret the Resignation of Judge William Connell effective December 31, 2020

The motion was seconded by Councilwoman Perrotti and approved by a 6-0 voice vote. Councilman Bardi thanked Judge Connell for his many years of service, noting that Judge Connell has served eleven terms for a total of thirty-three years.

#### **MAYOR'S REPORT**

Mayor Spango thanked the Department of Public Works (DPW), the police department, the fire department, the office of Emergency Management (OEM) and the first aid squad for their efforts during and after Tropical Storm Isaias. Mr. Spango announced that PSE&G has a program to reimburse residents who were without power for longer than seventy-two (72) hours for spoiled food. Claims must be submitted to PSE&G by mid-September. Council is looking to schedule a meeting in the third week in September with the Lincoln Street volunteer committee. The Borough will be taking delivery of the new playground equipment this year for Harrison Park. The installation will be rebid this fall for installation next spring.

#### **COMMITTEE REPORTS**

#### FINANCE, ADMINISTRATION AND PERSONNEL

Councilman Bardi announced that a letter will be going out by the end of the week summarizing the final tax bill as presented earlier in the meeting. Mayor Spango will follow up with the County DPW for an update on the County's plan for mosquito control.

#### SHARED SERVICES

Councilman Trillo requested that the restoration of issuing field use permits be considered, noting that SCRAM was held successfully, and the Borough is considering running the fall soccer program.

## **PUBLIC WORKS**

Councilman Freda thanked the DPW and all emergency services for their storm response. The water tank maintenance program is scheduled to resume. Residents in Zone 1 may experience pressure changes or dirty water. Affected residents will be notified prior to commencement of the work. All residents are asked to monitor their lawn sprinkler systems between August 24<sup>th</sup> and September 30<sup>th</sup>, and to voluntarily restrict sprinkler use to odd/even days depending upon street number, or to shut systems off completely.

#### REDEVELOPMENT AND LEGAL

Councilwoman Fishman confirmed that improvements to Harrison Playground will take place next spring. A local resident has been and will continue to make regular donations to the Borough's food pantry. The Borough has been and will continue to collect and deliver food weekly.

# **PUBLIC SAFETY**

Councilwoman Perrotti reported that the West Essex Board of Education has presented their reopening plan. Schools are tentatively scheduled to open September 2<sup>nd</sup> and 3<sup>rd</sup> for staff professional development, and for students on September 8<sup>th</sup>. June 22, 2021 is the projected last day of school. The Board has proposed a five-phase plan to bring students back to 100% capacity, but the dates are fluid and based upon the Governor's orders.

#### RECREATION AND COMMUNITY OUTREACH

Councilwoman Tolli reported that Roseland will be applying the \$150,000 Essex County Recreation Grant toward improvements to local playgrounds and parks. Mrs. Tolli thanked the DPW for watering the planters and hanging baskets around town. The library has reopened from 10:00 AM until 5:00 PM Monday through Friday, and from 9:00 AM until noon on Saturdays. The second movie night went well, the Recreation Department will be offering a new whiffle ball program, and the annual Run 4 Roses has been cancelled.

Mayor Spango added that the Borough is continuing to plan for the annual bonfire in hopes that the Covid-19 restrictions will be lessened by then. The bonfire is scheduled for Saturday, October 3<sup>rd</sup>. The night was changed to Saturday in anticipation of having a daylong community event culminating with the bonfire. The Borough has loaned the Library a temperature scanner for employees and patrons, and provided the Library with a stock of face masks.

## **APPROVAL OF MINUTES**

Council voted 4-0 to approve the January 22, 2019 Executive Session minutes with Councilman Bardi, Councilwoman Fishman, Councilman Freda, and Councilwoman Tolli voting in the affirmative, and Councilwoman Perrotti and Councilman Trillo abstaining.

Council voted 5-0 to approve the March 19, 2019 Executive Session minutes, the April 2, 2019 Executive Session minutes, the April 23, 2019 Executive Session minutes, the May 7, 2019 Executive Session minutes, the May 23, 2019 Executive Session minutes, the June 6, 2019 Executive Session minutes, and the August 11, 2020 Council meeting minutes with Councilman Bardi, Councilwoman Fishman, Councilman Freda, Councilwoman Tolli, and Councilwoman Perrotti voting in the affirmative, and Councilman Trillo abstaining.
