# COUNCIL MEETING MINUTES

Due to the ongoing Coronavirus (COVID-19) emergency, the April 20, 2021 meeting of the Roseland Mayor and Council was called to order at 6:00 PM via teleconference by Mayor Spango. # SALUTE TO THE FLAG

Mayor Spango led the salute to the flag.

#### PUBLIC COMMENT

Lauren Seiner from the Roseland Library announced the winners, their guesses, and the prizes for the recent jelly bean counting contest

Ms. Seiner reported that there were over one hundred entries to the contest, and that the actual number of jelly beans was 3,140, weighing seventeen pounds. Ms. Seiner thanked the mayor and members of Council for donating the contest prizes.

Councilman Bardi made a motion to introduce Ordinance No. 12-2021: "An ordinance to amend Chapter 20 of the Revised General Ordinances of the Borough of Roseland entitled "Soil and Soil Moving". The motion was seconded by Councilwoman Perrotti and approved by a 5-0 voice vote (Fishman absent). The public hearing will be held on May 18, 2021.

Councilman Trillo made a motion to introduce Ordinance No. 13-2021: "Bond Ordinance providing for improvements to tennis courts in and by the Borough of Roseland, in the County of Essex, New Jersey, appropriating \$124,000 therefor and authorizing the issuance of \$117,800 bonds or notes of the Borough to finance part of the cost thereof.". The motion was seconded by Councilwoman Tolli and approved by a 5-0 voice vote (Fishman absent). The public hearing will be held on May 18, 2021.

Roseland and substitute therefore salaries and compensation for the year 2021". Councilman Freda made a motion to open the public hearing on Ordinance No. 08-2021. The motion was seconded by Councilwoman Perrotti and approved by a 5-0 voice vote (Fishman absent).

#### MAYOR'S REPORT

Running for Answers, which supports Alzheimer's research, is scheduled for this Saturday, April 24<sup>th</sup>. Last week was the first week Since August 2020 with no new cases of Covid-19 reported. Work at Borino Park is progressing with some of the playground equipment installed.

# **COMMITTEE REPORTS**

# FINANCE AND ADMINISTRATION

Councilman Bardi congratulated Ryan Schwertfeger on his promotion to Public Information Officer. The hearing on adoption of the 2021 municipal budget is scheduled for the May 4<sup>th</sup> Caucus meeting.

Mayor Spango added that quotes are being solicited to construct a turf field at O'Beirne Field. Preliminary plans are underway for summer concerts, summer movies, and Roseland Day in October. Plans for Roseland Day include an internal, town soccer tournament, food truck festival, lighting of bonfire, and a culminating with a movie. The Borough is working on new signage reflecting the increased fines and mandatory court appearance for large truck that use Lincoln Street. Efforts to get GPS routes to direct traffic away from Lincoln Street appear to be working.

#### COMMUNITY SERVICES AND OUTREACH

Councilwoman Tolli wished Recreation Director Colitti a happy birthday. Fifteen students on the Municipal Youth Guidance Subcommittee are planning to visit the Community Food Bank in Hillside on May 1<sup>st</sup>. Covid-19 precautions will be followed and the students will assist with sorting and boxing food for distribution. Opening day baseball is scheduled for Saturday, April 24<sup>th</sup> beginning at 11:00 am.

#### REDEVELOPMENT AND LEGAL

#### PUBLIC WORKS

Councilman Freda introduced Joanna Bermingham from Remington & Vernick Engineers who explained status of water tank painting project. The project has been on hold over the course of the winter and the painting was postponed until spring to deal with some water valve issues. The ideal time to paint a water tank is in the spring or fall. Recently, Essex Fells has expressed concern over taking the water tank offline because several of their water operators have either retired or left the system. Essex Fells is concerned that the new operators are just learning the system, and may not be able to meet peak demand that comes with spring and summer. Ms. Bermingham presented to options:

The Borough can move forward and paint the exterior of the tank now, and then come back in the fall, take the tank offline, and paint the interior of the tank. The negative to this approach is the potential for condensation on the exterior of tank. Condensation may prevent the paint from adhering to the tank; or

The Borough can postpone the project until the fall, when the weather is more suitable for painting the tank. It will be cheaper to leave scaffolding in place over the summer than to remove the scaffolding now and then reinstall it in the fall. Council asked Ms. McDonnell to contact Essex fells to see if they will cover the cost of leaving the scaffolding up over the summer, and ask when Essex Fells expects to be comfortable allowing the tank being taken offline for painting.

#### PUBLIC SAFETY

Councilwoman Perrotti reported that the Office of Emergency Management (OEM) auxiliary police performed sixty-seven hours of traffic control and continued in-service training during the past month. The auxiliary police also assisted with the Easter Bunny drive around town. The OEM has two, new, electronic sign boards that have been placed around town with Covid-19 messaging. The draft fire department ordinance has been transmitted to fire department for their comments. The fire department reported thirty-seven members in March, conducting one meeting, two drills, and responding to eighteen alarms. This compares to thirty-seven alarms during March of 2020.

The West Essex Board of Education reported that the cohorts are going well. Mrs. Perrotti noted that the American flag at Fernwood Field is deteriorating and asked if the flag could be replaced before baseball opening day. Mayor Spango added that baseball opening day will be held at O'Beirne Field this year because there is more room to maintain social distancing. Mr. Spango asked Mrs. Chumacas to have the DPW take a look at the flag at Fernwood Field.

#### RECREATION

Councilman Trillo reported that the high school is now conducting a single cohort with students going in five days a week for half days. The middle school is still doing a hybrid offering. Noecker School is scheduled to begin five days per week next week, with students attending half days.

Pool membership applications will be posted on the recreation website very soon. The Fairfield Pool will be closed this summer. Roseland residents can still make application for the pools in Livingston, West Caldwell, North Caldwell, and East Hanover. All of the lights at all of the fields have been repaired. Opening day baseball is this Saturday. Mayor Spango added that multi-purpose court is about to be resurfaced and lined for street hockey and whiffle ball. T-ball has kicked off Sundays at O'Beirne Field with fifty children registered.

Mr. Trillo acknowledged the great job of customer service by Mrs. Maria Porreca, the new part-time recreation assistant. SCRAM registration is open. Whiffle ball begins next Friday and Pitch Hit and Run is scheduled for June 11<sup>th</sup>. With the closing of Eagle Rock Lanes, recreation is looking into scheduling the father child bowling event at Hanover Lanes. The Senior Luncheon, normally held in June, is being rescheduled for the fall. Councilman Trillo made his first visit to Camp Wyanokie on Sunday and assisted with the spring cleanup. Camp Wyanokie day is being rescheduled to the fall, tentatively on October 16<sup>th</sup>.

Mayor Spango noted that recreation cancellations are now being posted on the Borough's website and social media outlets. Councilman Trillo made a motion to reduce the Covid-19 sanitation fee for non-sanctioned groups by fifty percent, and to reduce the fee for sanctioned groups to a \$25.00 flat fee. The motion was seconded by Councilwoman Tolli and approved by a 5-0 voice vote (Fishman absent).
