This meeting was also available via Zoom conference call.

MAYORAL APPOINTMENTS

CONSENT AGENDA

Councilwoman Perrotti made a motion approve Raffle Application No. RA-389 for SS Nicholas Constantine and Helen Greek Orthodox Church to Conduct an Off-Premise 50/50 Raffle on March 27, 2022. The motion was seconded by Councilwoman Fishman and approved by a 6-0 voice vote.

MAYOR'S REPORT

Mayor Spango explained that one of the pieces of equipment in Borino Park had to be closed to investigate the cause of a couple of injuries. The Borough is awaiting a report and solution from the manufacturer. Mr. Spango thanked the police department, fire department, first aid squad, Office of Emergency Management (OEM), Department of Public Works (DPW), Ryan and Neal for assisting in the first summer concert and the first drive in movie of the summer. The next concert will be on August 4th in the parking lot next to the Harrison Avenue tennis courts, and the next drive-in movie will be the following week.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi reported that State has approved the budget so the new tax bills are scheduled to be mailed within the next two weeks. Tax payments will be due twenty-five days from the date of mailing. A letter will also be enclosed describing how the bill was calculated.

COMMUNITY OUTREACH & SHARED SERVICES

Councilwoman Tolli announced that the senior transportation bus is running Mondays through Fridays and will accommodate fifteen riders. Senior duplicate bridge will Monday

August 9th from 12:15 PM until 4:00 PM and will continue every Monday. The Roseland relief food bank is accepting non-perishable food donations and Mrs. Tolli thanked all those who have donated items to date. Mrs. Tolli invited Roseland high school students and any other Roseland residents who wish to perform community service, to join the Municipal Youth Guidance Subcommittee to assist the Roseland Historical Society with the clean out the Becker Farm barn. The cleanup has been scheduled for Saturday, August 21st and Sunday, August 22nd from 10:00 AM until 4:00 PM.

Mrs. Tolli thanked members of the DPW for watering the planters and hanging plants around town. The Roseland Junior Women's Club is collecting used towels and blankets that will be donated to area shelters that are housing dogs and cats. The Greek Church on Laurel Avenue will be hosting its annual Greek Festival on September 24th through September 26th. The next summer concert is scheduled for August 4th in the parking lot by the tennis courts, and the next movie night is scheduled for August 11th at Our Lady of the Blessed Sacrament Church parking lot.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman reiterated that repairs are pending on the playground equipment at Borino Park. Earlier in the meeting, Council awarded the contract for the improvements to the Harrison Avenue tennis courts and the basketball court at Tedesco Park. The Centers for Disease Control has again changed their guidance and is now recommending that those who have received the Covid-19 vaccination wear masks indoors. The Roseland Covid-19 Relief Fund remains active and is accepting donations and there are still people in need. There will be a butterfly safari tent at the Essex County Environmental Center all week. Anyone interested in attending will have to call for reservations and there is a fee, but the event should be a lot of fun for children.

PUBLIC WORKS

Councilman Freda announced that the road resurfacing project is scheduled to begin during the week of August 18th. Work is scheduled to begin with the replacement of storm drains on Second Avenue, and progressing to Woodland Road, Browning Court and Thackeray Drive. The project will take about twenty-one days to complete. Residents will be notified before work begins on their street.

PUBLIC SAFETY

Councilwoman Perrotti reported that the volunteer fire department currently has forty members. The department held one meeting, conducted two drills, and responded to fourteen alarms in June. The department has responded to a total of seventy-eight alarms this year, compared to eighty-five during the same period last year. The department also provided mutual aid to the Irvington Fire Department on June 8th during the funeral services for a fallen Irvington firefighter. The OEM provided traffic assistance for the summer concert, the drive-in movie, SCRAM events, and Saturday and Sunday services at Our Lady of the Blessed

Sacrament Church. They also provided traffic assistance for former Mayor DeBell's funeral. A total of one-hundred-man hours have been logged this month at no cost to the Borough.

Police Department Officer-In-Charge Costello informed Mrs. Perrotti of a new scam to watch for, aimed primarily at the elderly. The scam solicits cash like other scams, but the perpetrators come to the home to collect the cash, rather than having it wired. The police department cautions residents to contact the police department regarding any solicitations that they are uncomfortable with. Mayor Spango added that there is also an unemployment scan where people are filing for unemployment benefits for others. If any resident receives any unemployment claims that they did not file, they should immediately notify the police department and have an incident report generated, and they should notify the unemployment office.

RECREATION

Councilman Trillo reported that the summer SCRAM program has been very successful and is winding down. Registration for fall soccer will continue through next week, and registration for cross country will begin next month. The recreation booster club has reorganized and is working on raising funds in hopes of reopening the concession stand.

Councilwoman Fishman made a motion to approve the July 6, 2021 caucus meeting minutes and the July 6, 2021 executive session minutes. The motion was seconded by Councilman Trillo and approved by a 5-0 voice vote with Councilwoman Tolli abstaining from the vote.

Councilwoman Tolli made a motion to approve the July 16, 2021 special Council meeting minutes. The motion was seconded by Councilman Bardi and approved by a 3-0 voice vote, with Councilwoman Fishman, Councilman Freda and Councilman Trillo abstaining from the vote.

Councilwoman Perrotti made a motion to approve the July 16, 2021 executive session minutes. The motion was seconded by Councilman Bardi and approved by a 4-0 voice vote with Councilwoman Fishman and Councilman Freda abstaining from the vote.
