Mayor Duthie acknowledged that this will be his last meeting as Mayor. Mr. Duthie thanked everyone who supported him throughout his tenure, especially his wife Lisa and son Chris. Mr. Duthie also thanked his entire family, his business associates, and his supporters. Mayor Duthie noted that his service to the Borough began as a member of the Zoning Board of Adjustment, after which he ran for and was elected to Council in 2006 to fill a one year unexpired term for 2007. Mr. Duthie was then re-elected to a full three-year term from 2008-2010. In 2010, Mr. Duthie was elected to his first of two, four-year terms as Mayor, serving from 2011 through 2018. Mayor Duthie wished everyone a Merry Christmas and the best New Year ever.

COMMITTEE REPORTS

PUBLIC WORKS

Councilman Smith thanked borough residents for their support over the years and expressed his appreciation for the opportunity to serve. Mr. Smith stated that he did his best to represent everyone, for the Borough's best interest. Mr. Smith thanked his wife, his kids, and his fellow Council members for their support.

PUBLIC SAFETY

Councilman Jacobs thanked the Police Department, the Fire Department, the Office of Emergency Management, and the Department of Public Works for their response to the recent snow storm which snarled traffic and closed highways for hours. Mr. Jacobs also thanked the same departments for their year round service to the Borough. Councilman Jacobs wished everyone a Merry Christmas, and a Happy and Healthy New Year.

CAPITAL IMPROVEMENTS

Councilman Leonard commented on the recent Menorah lighting and Tree lighting, adding that the annual Santa ride will take place on December 23rd beginning on Laurel Avenue. Mr. Leonard remarked that the Roseland Fire Department does an excellent job of synchronizing the lights and music.

Councilman Leonard reported that the water main replacement on Belaire Drive, Belaire Court, Conover Avenue, and Cobb Terrace has been completed, with the only items outstanding

being submission of the as-built plans and the maintenance bond. Mr. Leonard stated that during the excavation, it was observed that the 12" main installed on Davenport Avenue, sometime in the 1960's, still appears to be in great shape.

Mr. Leonard wished everyone a Merry Christmas and hoped that those who celebrated Hanukah, enjoyed a great time with their families.

PUBLIC AFFAIRS

Councilman Bardi announced that the next budget meeting will be held on Saturday, January 19th at 10:00 AM. Mr. Bardi thanked Mayor Duthie, Councilman Smith, and Councilman Tsilionis for their service to the Borough. Councilman Bardi wished everyone a safe and happy holiday.

ADMINISTRATION & FINANCE

Councilman Tsilionis remarked that this was his last Council meeting as well. Mr. Tsilionis added that is has been a rewarding and challenging nine years.
