MAYOR'S REPORT

Mayor Spango announced that blue lights have been displayed on the municipal building at 140 Eagle Rock Avenue to commemorate Hannukah. The lights will be changed to red for Christmas. The menorah lighting ceremony will take place on November 29th, and the Christmas tree lighting ceremony will take place from 5:00 PM until 9:00 pm on December 4th. Mayor Spango thanked the recreation committee and the special events committee for their work organizing the event, and thanked the library for several donations for the event. There will horse drawn carriage rides, a trackless train, refreshments, carolers, and Santa will arrive at 7:00 PM. Mayor Spango wished everyone a restful, happy, and healthy Thanksgiving holiday.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi announced that the Borough's Verizon Public, Educational, Government (PEG) channel has been upgraded to high definition. In the process, the channel designation has been changed from 46 to 2146. Mr. Bardi wished everyone a Happy Thanksgiving.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli reported that the Beautification Committee met last week to prepare forty wreaths that have since been installed along Eagle Rock Avenue. The committee is also working on placing holiday plants in the various planters around town. Mrs. Tolli thanked the companies that donated equipment and manpower for the recent cleanup of the Bond Force Park brook, and the volunteers who assisted. Companies that participated include Thomas J. O'Beirne & Co., Northeast Products, Ventola Landscaping, Broheimer Tree Service, Jesse Landscaping, and James Haas Landscaping. Mayor Spango thanked Tom O'Beirne for spearheading the project, noting that the cost would have been approximately \$75,000.00 without the manpower and equipment donation, and the volunteer assistance.

Members of the Municipal Youth Guidance Subcommittee collected donations of approximately five hundred pounds of food two and half weeks ago at the West Caldwell Shop-Rite. The food will be distributed to the Roseland Food Bank, Our Lady of the Blessed Sacrament Church, and the Caldwell-West Caldwell Food Bank. On December 1st, members plan to prepare gift boxes to be sent to our troops for the holidays.

The new Senior Society is holding a meet and greet on December 2nd at Ss. Nicholas, Constantine, and Helen Church on Laurel Avenue. The Roseland Junior Women's Clubs has placed a collection box has been placed at the entrance of the Roseland Library for donations of new socks and underwear for distribution to local shelters. Gently used winter scarves, hats and gloves will also be accepted. The collection drive runs through November 30th. Mrs. Tolli wished everyone a Happy Thanksgiving.

PUBLIC WORKS

Councilman Freda thanked all of the volunteers who helped with the brook cleanup at Bond Force Park. Mr. Freda noted that earlier in the meeting, Council approved the fire department's participation in a holiday parade in Woodland Park on November 27th. Mr. Freda added that if you haven't seen the parade, it is well worth attending to see all of the fire trucks and emergency vehicles decorated with holiday lights.

PUBLIC SAFETY

Councilwoman Perrotti thanked the fire department for their participation in the holiday parade, noting that it is amazing to see how the trucks are decorated. The fire department held one meeting, two drills, and responded to twenty-two alarms in October. The fire department has responded to one hundred eighty-eight alarms to date this year, compared to one hundred fifty-three during the same period last year. The fire department also responded to mutual aid alarms in East Hanover on October 21st and on October 27th.

The Office of Emergency Management (OEM) auxiliary police provided traffic assistance for Saturday and Sunday services at Our Lady of the Blessed Sacrament Church, assisted the recreation department with the cross-country race and trunk or treat, and assisted with a large funeral. The auxiliary police also participated in an evacuation drill and holiday party at Noecker School. Mrs. Perrotti welcomed Pat Lorenzo back to the auxiliary police upon his return to New Jersey.

Mayor Spango reminded residents that free, weekly Covid-19 testing is available on Thursdays at the Bond Force Park building.

RECREATION

Councilman Trillo reported that the kickball season has concluded, and the cross county and soccer seasons are wrapping up as well. Mr. Trillo commented on the great atmosphere at the Harrison recreation complex on Friday nights. Basketball and other winter sports seasons are scheduled to begin the week after Thanksgiving. Councilman Trillo wised everyone a Happy Thanksgiving.
