# **PRESENTATION**

Police Department Officer in Charge Captain Costello reported that a bullet round was found in a wall in a home on Thackeray Drive recently. The incident is under investigation. In response to the continuing problems of car break ins and thefts in the Roseland and surrounding communities, patrols have been increased in the affected areas. In response to a commercial break-in, the police department has increased patrols in that area as well. The police department has one suspect in custody and has a good lead on a possible second suspect.

Mayor Spango added that the police department is being vigilant and the department has been taking proactive measures to address these issues. Assistance is also being provided to the police department by Essex County and New Jersey agencies. Mr. Spango also noted that the Roseland police department did a great job with a one day turn around on making an arrest in the commercial break-in.

#### COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli announced that the members of the Municipal Youth Guidance Subcommittee will be assisting at the New Jersey Food Bank in Hillside on January 22<sup>nd</sup>. This is the only event planned at this time. Senior bus service remains available to residents. The holiday story time began on the Borough's PEG channels last night on FIOS Channel 46 and 2146 and Comcast channel 35. Beginning in January, FIOS Channel 46 will be shut down in lieu of new channel 2146. The reading of the holiday stories will be televised every day at 8:00 AM, 12:00 noon, 6:00 PM, and 8:30 PM through January 7<sup>th</sup>. ### REDEVELOPMENT AND LEGAL

### PUBLIC SAFETY

Councilwoman Perrotti thanked the Roseland fire department and everyone who helped with the awesome Santa ride around town. Chief Loveless advised that a record number of people observed the event. The fire department has responded to one hundred seventy alarms to date this year. The fire department conducted two drills and held one meeting in November. The department responded to a fire at 465 Eagle Rock Avenue in November. The fire department also participated in a lights and sirens drive by on November 7th in West Caldwell for a very ill seven-year-old girl. The fire department participated in the 2021 Totowa West Paterson holiday parade on November 26th. The department placed first in best decorated fire engine, second in best decorated Chief's vehicle, and second in best overall. Members of the fire department paid their final respects to former Fire Chief George Batta on November 28th at the Shook Farmer Funeral Home.

The Office of Emergency Management (OEM) volunteered forty-four hours of time assisting with traffic at Our Lady of the Blessed Sacrament church, the menorah lighting and tree lighting, and other holiday celebrations. The OEM also assisted with two funeral escorts. Mrs. Perrotti thanked the members of the OEM for their hard work at all of the Borough's special events.

Councilwoman Perrotti thanked the police department for their efforts in apprehending a suspect in the recent service station break-in. Council approved the police superior officer's contract earlier in this meeting. Council is currently vetting new police candidates with plans to hire in the beginning of 2022. Mayor Spango added that the recent contract negotiations with the DPW and the superior officers was very successful and that all parties worked very well together.
