# **MAYOR'S REPORT**

Mayor Spango announced that the Borough purchased five thousand reusable grocery bags and will be distributing them to Borough residents from 5:00 PM until 7:00PM this Thursday at the tennis courts on Harrison Avenue. There will be a limit of three bags per family. The first summer concert is scheduled for July 13<sup>th</sup> and the second concert is scheduled for July 26<sup>th</sup>.

# **COMMITTEE REPORTS**

## FINANCE AND ADMINISTRATION

Councilman Bardi announced that estimated tax bills will be sent out shortly as the state has not yet adopted their budget. Mr. Bardi thanked Mayor Spango, Chris Critchett, and the Department of Public Works (DPW) for their part in making the annual barbecue a great success. More than four hundred food vouchers were distributed, and attendance was estimate at more than six hundred. Mayor Chris DPW at barbecue over four hundred food vouchers over 600 people enjoy the summer.

#### COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli repeated the details of the distribution of free grocery bags this Thursday. The food pantry is in need of donations to replenish supplies for local families in need. A list of suitable items needed can be found on the Borough's website. The Junior

Women's Club is sponsoring a Make Your Own Sundae on Wednesday, July 27<sup>th</sup> from 6:30 PM until 8:00 PM at the Roseland First Aid Squad building. The cost is \$3.00 per person and proceeds will be donated to Emmanuel Cancer Foundation, which specializes in pediatric cancer. The senior society will be taking a break during the summer months and Friday meetings will resume in September. The senior bus is available to take local seniors to various stores in the area. The summer concert series begins with Jersey Sound on July 13<sup>th</sup>, with subsequent concerts on July 26, August 17<sup>th</sup>, and September 17th. There are still free tickets available for seniors to attend the Lettermen concert at PNC Arts Center on Thursday. The bus will be leaving the Harrison tennis court parking lot at 10:45 AM. The library is conducting a book sale tomorrow from 10:00 AM until 8:00 PM and again on Thursday from 10:00 AM until 3:00 PM.

#### REDEVELOPMENT AND LEGAL

Councilwoman Fishman explained that completion of the improvements to the pickle ball, tennis, and basketball courts have been delayed due to supply chain issues. Council hopes that the work will be completed by August 17<sup>th</sup>. Mayor Spango added that the Borough Engineer has been working on his own to expedite delivery of the needed supplies to complete the projects. Mr. Spango also explained that the Borough had to adopt the bond ordinance on tonight's agenda in order to apply for a federal grant to upgrade all of the fields at the Harrison complex.

#### **PUBLIC WORKS**

#### PUBLIC SAFETY

Councilwoman Perrotti reported that the Auxiliary Police performed forty-five hours of traffic control for services at Our Lady of the Blessed Sacrament Church, family night at Noecker School, the West Essex Memorial Day Parade, and the borough picnic. The Office of Emergency Management (OEM) was instrumental in getting the location of the traffic camera at Noecker School relocated, resulting in improved traffic flow during non-school hours.

The OEM and Auxiliary Police responded with the fire department to Arbor Terrace for a water alarm that turned out to be a fire sprinkler activation. The Fire Department held one meeting and conducted two drills in May. The department has responded to sixty-four alarms this year to date. The department also responded to a request for mutual aid to West Orange. The fire department is in need of volunteers as two active members are leaving due to job relocations.

#### RECREATION

Councilman Trillo reported that the father child bowling event was held this past Friday at the Hanover Lanes, with more than one hundred participants. It was the first time the vent

was held since 2019. June 30<sup>th</sup> is the cutoff for fall sports including soccer, cross country and girls field hockey. Registration is currently available for summer programs on Community Pass for coed wiffle ball and men's basketball. Baseball season has concluded with only all-star games left.
