INTRODUCTION OF ORDINANCES

Councilman Trillo made a motion to introduce Ordinance No. 15-2022: "Bond ordinance providing for various capital improvements in and by the Borough of Roseland, in

the County of Essex, New Jersey, appropriating \$6,038,804 therefor and authorizing the issuance of \$5,708,837 bonds or notes of the Borough to finance part of the cost thereof'. The motion was seconded by Councilwoman Tolli and approved by a 6-0 voice vote. The public hearing will be held on September 20, 2022.

Clerk Watkins read Ordinance No. 14-2022 by title only for the second time: "An ordinance amending and supplementing Chapter 2 "Administration" of the Revised General Ordinances of the Borough of Roseland entitled "Department of Police or Police Department". Councilwoman Fishman made a motion to open the public hearing on Ordinance No. 14-2022. The motion was seconded by Councilwoman Perrotti and approved by a 6-0 voice vote.

Councilwoman Perrotti made a motion to adopt Ordinance No. 14-2022. The motion was seconded by Councilman Bardi and approved by a 6-0 roll call vote.

MAYOR'S REPORT

Mayor Spango announced that the biggest concert of the summer to date is scheduled for tomorrow. The booster club will be cooking and the library has arranged for food vendors on the lawn. Plans for the Mayor's Ball on October 22nd are progressing.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi announced that the Kootz concert will be available for viewing on the Borough's TV channel beginning at 10:00 PM this evening.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli asked that residents be careful not to donate food for the Roseland Food Bank that is beyond its expiration date. Senior citizen meetings will resume on Friday, September 9th. A trip for seniors is scheduled to PNC Arts Center for a concert on September 13th. Mrs. Tolli announced that there are two upcoming shared service programs with East Hanover. A "Move" exercise class will be held on Wednesday, August 28th a Lurker Park in East Hanover. A 24-week program called "Healthy Bones" will also be held at Lurker Park. The Municipal Youth Guidance Subcommittee will be scheduling their first meeting of the new school year in September to begin planning the year's activities. The next summer concert is scheduled for tomorrow night and the final concert of the summer will be on September 9th. There will be a barn sale and picnic on August 27th at the Becker Barn.

Mayor Spango added that Roseland has scheduled the 2nd annual Roseland Day on October 1st. Pickle ball and corn hole tournaments will be added to the activities form last year.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman reiterated that the basketball court at Tedesco Park has reopened and is currently being used for an adult men's basketball tournament. The new pickle ball courts at the Harrison Avenue complex have been well used to date.

PUBLIC WORKS

Councilman Freda made a statement to clear up some confusion.

PUBLIC SAFETY

Councilwoman Perrotti announced that the Roseland Fie Department held one meeting, conducted two drills, and responded to twenty-seven alarms in July. The department has responded to one hundred fifteen alarms this year, twelve more than the same time period last year. The fire department participated at the July 13th concert in an effort to recruit new members.

The Auxiliary Police provided thirty-two hours of traffic control in July at Our Lady of the Blessed Sacrament Church. The Office of Emergency Management (OEM) has home Covid-19 test kits available at no cost by calling 973-403-6840. The Roseland Historical Society will be hosting a garage sale at the Becker Barn on August 27th from 10:00 AM until 4:00 PM.

RECREATION

Councilman Trillo announced that men's summer outdoor basketball league wrapped up last night. Fall soccer practices began this week and cross-country plans to start the first week in September. Adult kickball has returned on Friday nights. Councilwoman Tolli added that the Run-4-Roseland and the Junior Olympics are scheduled for September 24th. Registration is available through the recreation office.
