## **PUBLIC AFFAIRS**

Councilwoman Tolli reported that the Beautification Committee will be looking into replacing planters in the center of town with barrel planters. The current planters look similar to trash cans, and people are discarding trash in the platers. Mayor Duthie asked about adding hanging baskets in the center of town similar to those in Verona. Mrs. Chumacas reported that money has been budgeted to purchase hanging planters and the equipment necessary to water the planters.

### ADMINISTRATION & FINANCE (Vidovich)

Councilman Vidovich reported that the draft budget incorporating changes suggested at the last budget meeting has been distributed to members of the governing body. Mr. Vidovich noted that the proposed budget reflects a ½ pct. increase to the average taxpayer and that the overall tax increase will be below 2%. Councilman Vidovich emphasized that the budget contains funding for important infrastructure projects and also reflects the retirement of additional debt. Mr. Vidovich thanked everyone for their work on the budget and announced that the 2017 Municipal Budget will be introduced at the March 28, 2017 Council Meeting and that the public hearing will be held in April. Mayor Duthie thanked Councilman Vidovich and Administrator Chumacas for their hard work in preparing the budget for introduction.

Councilman Vidovich briefly discussed a request from Verizon for authorization to install communication nodes on existing utility poles throughout the Borough. Mrs. Chumacas added that a resolution will be prepared for the consideration at the next meeting. Councilman Vidovich

requested that the change of the date of the next meeting be promoted on the borough's social media outlets.

Councilwoman Tolli announced that the West Essex drama club is presenting the Little Mermaid on March 9<sup>th</sup>, 10<sup>th</sup>, and 11<sup>th</sup>. Tickets can be purchased at the door, or on the West Essex high School website.
