Councilwoman Tolli seconded the motion and the motion was approved by a 5-0 voice vote (Tsilionis absent).

Councilman Vidovich seconded the motion and the motion was approved by a 6-0 voice vote, with Councilman Leonard abstaining from the vote on Resolution No. 270-2017.

COMMITTEE REPORTS

PUBLIC WORKS

After discussion, Councilman Smith made a motion to approve **Resolution No. 259-2017** authorizing the submission of an application for a 2018 NJDOT Municipal Aid Grant to resurface Roosevelt Street. The motion was seconded by Councilwoman Tolli and approved by a 6-0 voice vote.

Council discussed the purchase of another batch of water meters and wireless readers at a cost of \$250,000.00. Council asked Administrator Chumacas to report back to Council with an estimate to purchase enough meters for all residential properties, as well as an estimate to have an outside vendor install the meters.

PUBLIC SAFETY

Administrator Chumacas reported that correspondence has been received advising that William Transco is planning modifications to the natural gas compressor station in Roseland. Mayor Duthie added that Williams Transco declined an invitation to make a presentation to the public in 2017, preferring to appear in 2018 after their federal application has been filed.

RECREATION

Councilman Tsilionis asked for an update on the new recreation software which enables residents to register for and pay for recreation programs online, and whether there have been any complaints about the service fee. Mrs. Chumacas advised that residents are using the online option and that there have been no complaints to her knowledge. Mrs. Chumacas
