CAUCUS MEETING MINUTES

CALL TO ORDER & SUNSHINE STATEMENT

The January 2, 2018 Meeting of the Roseland Mayor and Council was called to order at 7:00 PM by Mayor Duthie. Adequate notice of the meeting was provided in accordance with the Open Public Meeting Act in that the date, time and location of the meeting was included in the Annual Meeting Schedule, was sent to the official newspapers, posted on the public bulletin board in the Municipal Building and filed in the office of the Borough Clerk.

The motion was seconded by Councilman Leonard and approved by a 6-0 voice vote.

CORRESPONDENCE

In lieu of his report, Mayor Duthie commented on two items of correspondence. The first was a complaint from Mr. Bob Faszczewski regarding alleged reckless drivers on Choctaw Way and exiting office parking lots onto Becker Farm Road. Mayor Duthie reported that the matter was referred to the Police Department, that he responded to the complainant, that he facilitated a meeting between the complainant and the Police Chief, and that the Police Department has increased patrols in the noted areas.

Mayor Duthie also reported that he received an e-mail from Vision Real Estate Partners located in Mountain Lakes, New Jersey, the new owners of 101, 103 and 105 Eisenhower Parkway, requesting a meeting to discuss the future use of the properties. Mayor Duthie asked for volunteers to serve on a committee to meet with the new owners, and a committee consisting of Councilman Jacobs, Councilman Bardi, and the Mayor was formed.

COMMITTEE REPORTS

PUBLIC WORKS

Councilman Smith reported that the Department of Public Works has completed the collection of leaves from the streets. Mr. Smith also noted that the DPW will begin collecting and recycling unbagged and unbound Christmas trees through at least January 16th, and asked that residents remove all wires and other materials from the trees. The DPW will also begin collecting tree branches on the first Monday of each month.

PUBLIC SAFETY

Councilman Jacobs noted that he has observed and has received complaints from residents that drivers are ignoring the traffic signals at the intersection of Eisenhower Parkway and Eagle Rock Avenue. Mr. Jacobs urged all residents to obey all traffic signals.

RECREATION

Councilwoman Tolli noted that the 2018 meeting schedule includes meetings on primary and general election days. After discussion, Councilwoman Tolli made a motion that the November 6th meeting be rescheduled to Thursday, December 8th at the regular time. The motion was seconded by Councilman Bardi and approved by a 6-0 voice vote.

Mrs. Tolli reported that the deadline to sign up for the Recreation sponsored ski trips has been extended until Friday. The Recreation Department needs thirty participants to cover the cost of the bus and only eighteen have signed up as of today.

CAPITAL IMPROVEMENTS

Councilman Leonard reported that his committee will have their first meeting on January 30th. Mr. Leonard expressed his desire that Council review the water maintenance plan and implement appropriate projects. Mr. Leonard also expressed his desire to see the resolution of the issues regarding the Borough assuming responsibility of the maintenance of the Roseland Green sewer pumping station.

Mayor Duthie added that he would like to see an ordinance get through committee that will address uniform maintenance of roads in all single family neighborhoods regardless of whether they are part of an association. Borough Attorney Sheffet noted that a global ordinance will clarify the Borough's responsibilities for maintenance of the private roads, but will also need to repeal ordinances previously adopted that are relative to specific condominium complexes.

PUBLIC AFFAIRS

Councilman Bardi thanked all residents who have volunteered to serve on various boards and committees. Mr. Bardi added that he will have a report available at the next meeting.

ADMINISTRATION & FINANCE

Councilman Tsilionis asked that budget meetings be scheduled to begin review of the 2018 municipal budget. Mrs. Chumacas noted that a draft budget will be complete in approximately two weeks. After discussion, Council agreed to schedule a budget review meeting at 9:00 AM on Saturday, January 20th at 140 Eagle Rock Avenue.
