MAYOR'S REPORT

Mayor Duthie announced that the Environmental Commission will be hosting an open public discussion on Saturday, April 7th from 9:00 AM until 10:00 AM at the public library.

COMMITTEE REPORTS

PUBLIC WORKS

In Councilman Smith's absence, Administrator Chumacas advised Council that the Deputy Superintendent of the Department of Public Works sent an e-mail explaining that the DPW will need to work overtime in order to get routine and emergency work completed. Without working overtime hours, the routine work of getting parks and fields ready for spring opening, and the quarterly water meter reading, would be delayed as a result of the effort required to cleanup tree damage caused by the recent spate of late season, heavy snowfalls.

PUBLIC SAFETY

Administrator Chumacas reported that Pierce Manufacturing has submitted two invoices totaling \$568,880.00 for progress payments on the new fire engine under construction. It is customary that payment not be made until the vehicle is delivered. The manufacturer has offered to give a reduction in the amount of \$11,000.00 if the invoices for progress payments are paid now. The total cost of the contract is \$890,000.00. After discussion, Council authorized CFO Chumacas to utilize her judgement to determine if the added cost of borrowing the money sooner to pay the bills now is worth the discount offered.

RECREATION

Mrs. Tolli reported that she has received an inquiry about the presence or removal of railroad tracks in the recently purchased railroad right of way. After discussion, Council believes that the tracks have been removed, but the ties remain.

CAPITAL IMPROVEMENTS

Councilman Leonard reported that the DPW is making good headway in picking up tree branches town wide.
