INTRODUCTION OF ORDINANCES

Councilman Bardi made a motion to introduce Ordinance No. 01-2021: "An ordinance to amend Section 2-6 entitled "Standing Committees of Council" and Section 2-22 entitled "Department of Public Works" of the Revised General Ordinances of the Borough of Roseland. The motion was seconded by Councilman Trillo and approved by a 5-0 voice vote (Freda absent). The public hearing will be held on February 16, 2021.

The motion was seconded by Councilwoman Perrotti and approved by a 5-0 voice vote (Freda absent).

MAYOR'S REPORT

Mayor Spango reported that there was a spike in December with eighty cases of Corona virus reported, and there have been six new cases reported thus far in January. Mr. Spango asked residents to remain vigilant. Mr. Spango noted that health care workers and EMTs are now eligible to get the Covid-19 vaccine, and encouraged those groups to get vaccinated as soon as possible. Mayor Spango congratulated Council members Tolli and Bardi on their reelection, congratulated all appointees, and thanked all those who have volunteered to serve on various committees.

COMMITTEE REPORTS

FINANCE, ADMINISTRATION AND PERSONNEL

Councilman Bardi congratulated Councilwoman Tolli on her reelection to Council, and Councilwoman Fishman on her election as Council President. Mr. Bardi thanked all those who volunteered to serve on committees. There will be a special budget meeting on Saturday, January 16th at 9:00 AM to discuss the water/sewer capital budget and the annual debt statement. There will be another special budget meeting scheduled on Saturday, January 30th at 9:00 AM to discuss the operating budget. Council plans to introduce the budget by March 30th and to adopt the budget by April 30th.

SHARED SERVICES

Councilwoman Tolli congratulated Councilman Bardi on his reelection to Council, and Councilwoman Fishman on her election as Council President. Mrs. Tolli thanked all those who have volunteered to serve on Committees. The Municipal Youth Guidance Subcommittee will be meeting shortly to determine their next project. The winner of the Municipal Youth Guidance scholarship will be announced at the next Council meeting. There has not been any recent Senior

Transportation Committee activity. The Senior Transportation bus is running. Mayor Spango noted that the Borough has received a bill from Caldwell for the full year of 2020.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman congratulated Councilwoman Tolli and Councilman Bardi on their reelection to Council. Mrs. Fishman congratulated all of the appointees and thanked all of those who have volunteered to serve on various committees. Bids were received today for improvements to Harrison Park. Essex County has opened five Covid-19 vaccination sites. All those in Group 1A, health care workers, doctors, EMT's, are eligible to get vaccinated now. Mrs. Fishman urged all those eligible to get their vaccination as quickly as possible. Residents can register to get the vaccination at www.essex.covid.org. The Borough has been and continues to receive donations to the food bank and the Roseland Covid-19 Relief Fund. The Borough continues to help with relief for seniors, and donations are still required as more people will have a need for assistance. Mayor Spango added that the Borough has established a list of seniors who are interested in getting the vaccine but do not have the technical ability to register online.

PUBLIC WORKS

Councilwoman Tolli thanked the members of the Department of Public Works (DPW) for the work cleaning up after the recent snow storm, and continuing to pick up branches.

PUBLIC SAFETY

Councilwoman Perrotti congratulated Councilman Bardi and Councilwoman Tolli on their reelection to Council, and congratulated Councilwoman Fishman on her election as Council President. Mrs. Perrotti congratulated all appointees and thanked all those who have volunteered to serve on committees. The fire department ordinance has been amended and after review by the committee, the ordinance will be forwarded to the fire department for their review. Mrs. Perrotti noted that the police department has suggested that a private company called Extra Duty Solutions could be used to schedule off-duty officers for off-duty construction jobs, freeing local officers from this scheduling duty. Mayor Spango added that the construction vendor would pay the Extra Duty Solutions fee, and the Borough would still receive administrative fees. Mr. Spango cautioned that state law requires that officers be paid by their respective municipalities so that officers would have disability protection while working the off-duty jobs.

RECREATION AND COMMUNITY OUTREACH

Councilman Trillo congratulated Councilman Bardi and Councilwoman Tolli on their reelection to Council, and Mrs. Fishman on her election as Council President. Mr. Trillo thanked all those who volunteered to serve on various committees.

Mrs. Perrotti added that the Recreation Department would like to expand the online gaming program to Fairfield and North Caldwell, for a minimal fee of between \$5.00 and \$10.00 to cover the cost of trophies. Council agreed to offer the program to Fairfield and North Caldwell, but at no charge. Any minimal additional cost can be absorbed by the recreation budget, where funds are available from programs that were cancelled due to Covid-19. Mayor Sango asked that Recreation Director Colitti ensure that any programs offered will be age appropriate. Mr. Trillo encouraged everyone to stay safe and have a happy new year.
