Councilwoman Perrotti made a motion to approve the three items on the Consent Agenda:

The motion was seconded by Councilwoman Fishman and approve by a 6-0 voice vote

MAYOR'S REPORT

Councilwoman Tolli made a motion to approve Resolution No. 86-2021 designating March 19, 2021 as Covid-19 Memorial Day in recognition of the victims and survivors. The motion was seconded by Councilwoman Fishman and approved by a 6-0 voice vote.

Mayor Spango announced that there were thirty-eight new cases of Covid-19 reported in February, down drastically from the ninety cases reported in January. No new cases have

been reported to date in March. This brings the total number of Covid-19 cases in Roseland to three hundred and ninety. A bill passed by the House of representatives last week will bring substantial financial relief to Roseland. The bill s expected to be approved by the Senate in the very near future. The Borough was featured in the March issue of New Jersey Magazine, recognizing the Brough's initiative to support the Roseland Covid-19 Relief fund with proceeds from the sale of custom face masks. The Borough will conduct a Covid-19 compliant Easter Egg Hunt on March 28th at 10:00 AM.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi announced that Council has the final budget meeting scheduled for tomorrow at 5:30 PM. Council plans to introduce the budget at the March 16th meeting.

Borough Attorney McDonnell explained that the first of two public notices have been advertised, announcing that Council will conduct a public hearing on the renewal of the Comcast cable television franchise at the April 13th caucus meeting. A representative from Comcast will make a presentation, and members of the public will be given the opportunity to ask questions and make comments on the renewal. After the public hearing is closed, Council will negotiate a renewal contract with Comcast in order to establish the terms and conditions of the ordinance that will authorize the contract. The draft ordinance will then be sent to the NJ Board of Public Utilities (BPU) Office of Cable Television for their review and approval. After the NJ BPU approves ordinance, Council can introduce the ordinance, after which the customary public hearing will be held.

COMMUNITY SERVICES AND OUTREACH

Councilwoman Tolli reported that the Municipal Youth Guidance Subcommittee, in cooperation with the Roseland Junior Women's Club, collected donations of 1,800 new pairs of socks and 300 gently worn pairs of socks. The socks were delivered to the Franciscan Friary in and to the Sisters of Mercy, both located in Newark. The socks will then be distributed to local shelters. Mrs. Tolli thanked Roseland and West Essex residents for their generosity. The Environmental Commission will be reaching out to the Principal at Noecker School to discuss establishing a butterfly garden on the school property. Mrs. Tolli noted that today is Doctor Seuss's birthday, and expressed concern about reports that there are plans to ban six of Dr. Seuss's books. Mrs. Tolli thanked Essex County, County Executive DiVincenzo, and all of the people staffing the Covid-19 vaccine site at the vocational school in West Caldwell for the safe and efficient process that has been set up. The Municipal Youth Guidance Subcommittee may want to go to a foodbank in Hillside in April, and if they go, they will follow Covid-19 safety guidelines.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman reported that there was a Harrison Park Improvement project preconstruction meeting yesterday, and another meeting is scheduled for tomorrow to discuss

the logistics of equipment delivery. Demolition work is scheduled to begin after tomorrow's meeting. The Roseland Covid-19 Relief Fund is still accepting, and is still in need of donations, as there are an increasing number of families in need. Mrs. Fishman thanked local residents and those from other communities for their generosity. The Roseland Food bank is accepting shelf stable goods and paper supplies. The Johnson and Johnson Covid-19 vaccine has been approved by the federal government. It is hoped that with the additional supply of the Johnson and Johnson vaccine, there will be enough vaccines available by the end of May, for all Americans who wish to be vaccinated. Mrs. Fishman encouraged anyone needing assistance with getting a vaccine to call the Borough Hall.

Mayor Spango added that plans are underway to open a Covid-19 testing site at the Roseland First Aid Squad building between March 6th and March 9th. Council hopes to open a vaccination site in Roseland as well. The Borough is compiling a list of home bound senior citizen residents who will be eligible to have the vaccine administered at their home.

PUBLIC WORKS

Councilman Freda cautioned residents about telephone fraud. Mr. Freda explained that he recently received a text message identified as coming from a bank, followed by a telephone call also identified as coming from the same bank, concerned about the possible fraudulent use of his bank card to make a purchase at an out of state store. During the ensuing conversation, the caller attempted to obtain Mr. Freda's card number and other account information, at which time Mr. Freda became suspicious and reported the call to the banks' fraud department.

PUBLIC SAFETY

Councilwoman Perrotti thanked the new cadet members and the new regular member of the fire department. Mrs. Perrotti asked about the Resolution that Council approved in support of the historical society's application for a grant.

RECREATION

Councilman Trillo reported that the recreation department is getting ready for the baseball and track seasons. Registrations are currently being accepted for baseball and softball and will continue for another two weeks. The recreation department hopes to get participants into the batting cages by the last week of March, weather permitting.

Councilman Bardi made a motion to approve the January 30, 2021 special budget meeting minutes, the January 30, 2021 executive session minutes, and the February 2, 2021 caucus meeting minutes. The motion was seconded by Councilman Trillo and approved by a 5-0 voice vote with Councilman Freda abstaining from the vote.
