#### INTRODUCTION OF ORDINANCES

Trillo and approved by a 5-0 voice vote (Tolli absent). The public hearing will be held on July 27, 2021.

The motion was seconded by Councilman Freda and approved by a 5-0 voice vote.

#### **CORRESPONDENCE**

Councilwoman Perrotti made a motion to approve the request received from Hillside Avenue, Condit Court and the upper end of Monroe Avenue to conduct a block party on Hillside Avenue on October 10<sup>th</sup> from 10:00 AM until 4:00 PM, with a rain date of October 17<sup>th</sup>. The motion was seconded by Councilman Trillo and approved by a 5-0 voice vote (Tolli absent). Mrs. Chumacas was directed to inform the requestor to contact the police department about closing the street and the requirements for barricades.

#### **MAYOR'S REPORT**

Council agreed to accept the low bid in the amount of approximately thirty-thousand dollars (\$30,000.00) to perform maintenance of the culvert behind the homes on Davenport Avenue. The culvert is located on a portion of the former railroad right-of-way that was purchased by the Borough. A fallen tree has become lodged in the culvert, blocking to flow of storm water. A resolution will put on the July 27<sup>th</sup> agenda for Council action.

The Roseland Historical Society has scheduled a cleanout this Saturday and Sunday, of the Becker Farm barn on Eagle Rock Avenue. The vision of the Historical Society is to make the barn an interactive museum of borough history. Council decided not to authorize overtime for Department of Public Works (DPW) employees to assist with the cleanup, in order to avoid setting a precedent for other no-for-profit organizations. Council will wait until after this weekend and assess the situation to see if DPW employees can provide any support during normal working hours.

The first summer concert is scheduled for next Tuesday night at 7:00 PM at O'Beirne Field. The next concert will be on Wednesday, August 4<sup>th</sup> at 7:00 PM. The first drive-in movie night is Wednesday, July 21<sup>st</sup> at 7:30 PM in the parking lot at Our Lady of the Blessed Sacrament Church. The second movie night will be on Wednesday, August 11<sup>th</sup> at 7:30 PM. One of the movies will be a children's movie and the other will be a family movie. Residents can still vote online for their choice of selected movies.

Council is in the planning stage for Roseland Day scheduled for October 9<sup>th</sup>. Festivities will include a Run 4 Roseland at 9:00 AM with finish line sponsorship signs. From approximately 3:00 PM to 6:30 PM there will be food trucks on site, with local bands performing. The bonfire will take place at approximately 7:00 PM, followed by a movie. Council is also planning to put out a calendar in 2022. All departments will have to submit dates for 2022 activities to Administrator Chumacas by November.

## FINANCE AND ADMINISTRATION

Councilman Bardi reported that the state has approved their budget and we are awaiting notice of the final tax rate. The Committee is working on an application for a Green Acres grant for next year. Awaiting clear guidelines for use of recovery money that has been given to municipalities The Borough has submitted a report to the state on lost revenue due to Covid-19. It is hoped that the Borough will be able to use recovery money to cover lost revenue. Final tax bills are expected to go out within the next two weeks. Mr. Bardi expressed his condolences to the DeBell family.
