INTRODUCTION OF ORDINANCES

The motion was seconded by

Councilman Trillo made a motion to introduce Ordinance No. 02-2023: "An ordinance creating a new Chapter 12 of the Revised General Ordinances of the Borough of Roseland entitled "Children's Fund", authorizing the creation of a Children's Fund and establishing administrative and procedural guidelines for the operation and management of said fund". PUBLIC SAFETY

Councilwoman Perrotti was pleased to see the amount of police department training that was on tonight's agenda. The fire department has responded to thirty alarms this month to date. The department responded to two hundred twenty-three alarms in 2022 compared to two hundred nineteen in 2021. The fire department has responded to a number of tough calls in the past few weeks and Mrs. Perrotti thanked the members for everything that they do. The OEM Auxiliary Police provided thirty-man hours of service in January helping with Santa's arrival and performing traffic control at Our Lady of the Blessed Sacrament church.

RECREATION

Councilman Trillo reported that basketball season is well underway. The glitch with the girl's uniforms is expected to be resolved within the next few days. Mr. Trillo was pleased to announce that pickup basketball is coming back thanks to Roseland Board of Education Superintendent Leone. Beginning the last Monday in January, the gym at Noecker School will be open to men and women over the age of eighteen every Monday night through April 24th for pickup basketball games.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli congratulated those members of the governing body who were reelected to another term. Mrs. Tolli commented on a number of shared services that will continue this year including animal control with West Orange, Construction Department services with Verona, Health Department services with East Hanover, and the senior bus with West Caldwell and Caldwell. Student members of the Municipal Youth Guidance Subcommittee (MYGS) are meeting tomorrow night at the first aid squad building to prepare sandwiches and lunches that will be distributed to homeless people at local shelters. The MYGS is awaiting a date when they will travel to assist at the New Jersey Food Bank in Hillside. The annual Noecker School tricky tray is scheduled for April 26, 2023.

REDEVELOPMENT AND LEGAL

Councilwoman Fishman commented that she and Councilman Freda had an enjoyable time at the recent Elks Hoop Shoot event, noting that it was a very nice time for the kids. The next meeting of the Senior Society is scheduled for January 27th. There will be a speaker from RWJ Barnabas health.
