COUNCIL MEETING MINUTES

The May 16, 2023 meeting of the Roseland Mayor and Council was called to order at 6:30 PM by Mayor Spango. This meeting was also available via Zoom conference call.

EXECUTIVE SESSION

Councilwoman Fishman made a motion to approve Resolution No. 171-2023 Approval to Close to Executive Session to discuss the following:
