MAYOR'S REPORT

Mayor Spango reported that the community picnic on June 3rd was a great success, with more than five hundred residents in attendance. Mayor Spango thanked the students at West Caldwell Tech who constructing a new manger for the Christmas holiday, saving the Borough the cost to purchase a new one. The first summer concert is scheduled for July 12th. Preliminary plans for the 2023 Christmas and holiday celebration have begun.

COMMITTEE REPORTS

FINANCE AND ADMINISTRATION

Councilman Bardi thanked the Roseland Police Foundation for their donation of the laser speed detectors. Mr. Bardi also thanked the Roseland Police Department for their increased efforts over past twelve months. A letter will be going out to all residents Letter going out soon to all residents explaining the upcoming townwide property revaluation. The County requires this process to be completed every ten years, and the last revaluation was in 2010. Council also expects to host a meeting for questions and answers regarding the process.

PUBLIC WORKS

PUBLIC SAFETY

Councilwoman Perrotti thanked the Roseland Police Foundation for their donation of the laser speed detectors. Mrs. Perrotti expressed her pleasure that Council has authorized the mayor to sign a Memorandum of Agreement with Essex County to enable the Borough to erect a License Plate Reader (LPR) on Livingston Avenue near the exit ramp from Interstate Route 280. The Borough also plans to erect another LPR on Laurel Avenue. The Borough is currently preparing a grant application for five more stationery LPR's.

Councilwoman Perrotti implored residents to remove their key fobs from their cars, lock their cars, lock their houses including the door from an attached garage into the home, and to call the police whenever they witness any suspicious activity.

RECREATION

Councilman Trillo stated that baseball and softball seasons are wrapping up. The $7^{th}-8^{th}$ grade girls softball team won their softball championship. Summer events kickoff with the senior barbecue which is scheduled for Friday, June 23^{rd} . The morning sessions of SCRAM are booked up, but there are a few openings in the afternoon session. Mr. Trillo announced the last call for adult men's basketball league which starts next week. All fall programming registrations are open including soccer, cross country, youth kickball, and the run walk event.

COMMUNITY OUTREACH AND SHARED SERVICES

Councilwoman Tolli announced that there are four summer concerts scheduled beginning with a country style band on July 12th. The schedule of all of the concerts is available on the Borough's website. The new term for the Municipal Youth Guidance Subcommittee starts in September and is open to all high school students in grades nine through twelve. There are three openings on the Environmental Commission. The library is conducting their annual book sale beginning today through Thursday from 9:00 AM until 3:00 PM. The Historical Society is holding a wine and cheese gathering on July 4th from 4:00 PM until 7:00 PM.

Mayor Spango added that all summer concerts are free to attend. Prior to the concert on July 12th, the graduating students from Noecker School will be acknowledged with a group photograph on stage.
