### **EXECUTIVE SESSION**

Councilwoman Fishman made a motion to approve Resolution No. 271-2022 Approval to Close to Executive Session to discuss the following:

## **MAYOR'S REPORT**

Mayor Spango thanked all those whose efforts made Roseland Day a resounding success, especially the recreation department, the department of public works (DPW), the booster club, the library, the pickle ball committee, Director Matheis, DPW Superintendent Critchett, and Recreation Director Colitti.

## **COMMITTEE REPORTS**

### **PUBLIC WORKS**

Superintendent of Public Works Chris Critchett was in attendance in person, and Kristen Kramer from Remington & Vernick Engineers was present via Zoom conference call for this portion of the meeting.

Council decided to reject the bids for the rebid of the installation of the auxiliary water storage tank, as the cost significantly exceeded the engineer's estimate for the project. Council decided to change the scope of the project from installation of a used, auxiliary water storage tank to the installation of a new 300,000-gallon water storage tank.

#### FINANCE AND ADMINISTRATION

Councilman Bardi explained the provisions of proposed ordinance No. 17-2022. After discussion, Council agreed to delete the entire section regarding "Temporary Business Licenses for Use on Public Property". Council also agreed to amend section 4-14.3c.4.a. of the proposed block party ordinance to require that the application for a block party permit shall require the signatures of a minimum of seventy-five percent of the owners of all of the impacted properties on the street or portion of the street where the block party is proposed.

Mrs. Chumacas advised Council that a resident of Mitchell Avenue has inquired if the Borough would be interested in selling him the adjacent lot owned by the Borough. After discussion, Council decided not to sell the property at this time.

Police Director Mathies showed Council an example of the proposed baseball cap and insignia to be worn with the department's Class C uniforms. Council approved the proposed design and authorized the Borough's purchase of the initial batch of caps.
