EXECUTIVE SESSION

Councilman Trillo made a motion to approve Resolution No. Resolution No. 72-2023 Approval to Close to Executive Session to discuss the following:

INTRODUCTION OF ORDINANCES

Councilwoman Perrotti made a motion to introduce Ordinance No. 06-2023: "2023 Bond Ordinance providing for various improvements to the water/sewer utility in and by the Borough of Roseland, in the County of Essex, State of New Jersey, appropriating \$3,100,000 therefore and authorizing the issuance of \$3,000,000 bonds or notes of the Borough to finance the cost thereof'. The motion was seconded by Councilman Trillo and approved by a 4-0 voice vote (Fishman, Freda absent). The public hearing will be held on February 21, 2023.

Councilman Trillo made a motion to introduce Ordinance No. 07-2023: "Bond Ordinance providing for various capital improvements in and by the Borough of Roseland, in the County of Essex, New Jersey, appropriating \$2,059,000 therefore and authorizing the issuance of \$1,866,750 bonds or notes of the Borough to finance part of the cost thereof'. The motion was seconded by Councilwoman Perrotti and approved by a 4-0 voice vote (Fishman, Freda absent). The public hearing will be held on February 21, 2023.

Councilman Bardi excused himself from the meeting following introduction of the two ordinances.
